# **President's Report,** By Mark Donahue

#### Contract

On Thursday, May 12th, the Mayor signed our contract which had been in force since the City Council adopted it on April 6th. Prior to leaving the Mayor's office, keeping in mind the [lack of] opportunities I have had for face-to-face time, I mentioned to both the Mayor and his attorney the importance of the issue of retiree health insurance. He actually seemed well aware of the importance of this issue and even remarked to the attorney about the need to address it in committee form in the near The court decision (Korshak) requires this committee to be in place by 2008.

### Legislation

HB 3597 passed out of the Senate on May 16<sup>th</sup>. legislation is now on its way to the Governor's desk for his signature. Once signed, it will permit retired members of the CPD to qualify to carry their weapons after 1 July in compliance with HR218, the federal legislation signed into law by President Bush. This bill, unlike the one introduced in the Federal Senate is free from the amendments that were attached to the other Rep. John Millner, (soon to be Sen. Millner), did a great job in keeping this bill free of any amendments. We are aware that there have been reports that there are individuals who claim to have the ability to qualify our retirees with the approval of the Training Standards joint committee to recom-

Board. This is not true. As soon as the qualification standards are established and implemented, we will inform you in this newsletter and on the web site as to the process for qualifying. Patience is the key here; don't be deceived by those who are not as yet sanctioned to qualify you. Also, the City of Chicago has finally consented to the 3% COLA increase bill for those born before 1955. It is now a foot race to get the bill passed either alone or as part of other related legislation before the end of the spring session. Currently, there are rumors that the session will be extended enhancing our ability to get them through.

## 10-Hour Pilot Program

In regards to the 10-hour Pilot Program that is underway in the Districts in Areas 1 and 5, there was a joint meeting held between the F.O.P. and the CPD to discuss the continuation of the program. In districts that have been implementing the program, there has been a good measure of success in having start times of 1400 hours during the week and 1600 hours on the weekend which bolsters the needs for added manpower when the schools get dismissed and also adds bodies for a needed presence around bars and taverns on the weekends. After extensive discussion on the attributes of the program there was a vote taken and it was the "unanimous" decision of the

mend to the Superintendent to continue the program through the end of the year and to give due consideration to expanding it at that time. Any expansion of the program would presumably be on a voluntary basis as there has been no need to backfill these positions anywhere in the City.

#### **Contract Books**

We are in the process of proofing the Agreement before sending it out to the printers. All working members will be able to obtain a copy of the Contract once we obtain them and we will also have the complete Contract on the web site. The officers in the Lodge are currently planning seminars to address the changes in discipline and will be writing articles in the near future to further identify other changes in the contract including those for your Medical coverage.

#### Get Involved!

Last month I addressed extensively the importance of our membership being involved politically to enable the Lodge to enhance your benefits and to retain what we have gained, in particular, that which we have obtained through the political process. This past month, we have seen examples of the importance of getting involved in the process. We have seen private industry strike a hefty blow in their ability to attack pension and worker rights. If anyone reading this does not believe there is movement to consider changes to our bene-

fits that have been obtained through the legislative process, you need to get a reality check. There has been talk around the state of revamping pension benefits in the State systems and with their ability to argue a need to do so, they could be taking others to school on how to address this volatile issue. It's never too early to ensure your retirement benefits will be there when you want them regardless of your years on the job.

## **Memorial Month Recap**

May has now passed and the participation by members of the Lodge at the memorial services at Soldier Field, Springfield, Washington and here at the Lodge was outstanding. For those of you in attendance you saw first hand the impact of your presence on the family members of the officers that were being honored. It really does mean a lot to the family members to see so

many of their loved ones' colleagues present in a show of respect. This May has also ushered in a new honor for many Officers who have been killed in the performance of duty and their families. Supt. Phil Cline has taken the bold step of changing the policy that has stood for decades for honoring Officers from the Chicago Police Department who have lost their lives in the performance of duty. These officers will now be added to the Superintendent's Honored Star Case at headquarters. This decision was long overdue and had caused dissension in the ranks in recent years over the inability of family members of those killed in the "performance of duty" to see their loved one's star hanging in such a prominent place. After the ceremony in which seven stars were retired to the "Case", the expressions on the faces of the family members as well as their demonstrations of appreciation, confirmed to all in attendance that the right decision had been made. The Lodge commends this bold decision by Superintendent Cline, allowing the stars of these seven Officers, with more to follow, to take their proper place in the history of the Chicago Police Depart-

## New Injury-on-Duty Doctors List

The Lodge has the new list of doctors from the Medical Services Section. The list has over 800 doctors to choose from. Officers should now be given a choice from any of the doctors on the list. I repeat; you can pick any of these doctors off the list. If you are told that you have to pick one of these three, or a particular doctor, ask to speak to a sworn supervisor. there are any problems relating to this please contact the Lodge and make us aware of the problem. The Lodge has begun to document a list regarding the quality of the medical care, or lack of, which you are receiving from

this new list of doctors. Call V.P. Bill Dougherty at the Lodge with this information.

# New PPO Plan starting in January 2006

The PPO Health Plan will have a wellness plan starting on January 1, 2006. Each family member will have \$600.00 to use toward well care. The wellness plan will cover routine exams by your doctor, immunization shots, mammograms and vision care. The wellness benefit is not subject to the Plan's annual deductible. When your open enrollment package comes in the fall, make sure that you go over it carefully so that you can become aware of all the new changes.

## Medical Benefits While On Military Leave

Medical benefits for an employee and his/her covered dependents will remain in force during the term of military leave. Premiums will not be deducted from the employee's paycheck. If an employee has a dependent who is covered by medical benefits and is ordered to report for military service, the dependent's coverage will terminate on the day such orders are received. When the dependent of the employee returns from military service, the employee must reinstate coverage by completing a dependent enrollment form within 30 days of the dependent's release from military service.

### **Firearms Safety Days**

The Firearms Safety Days were held at the F.O.P. Hall on the 24th & 25th of May. This year's event was a huge success with 390 officers attending the event. Each morning, officers were lined up outside the Hall before we even opened the doors. Officers from across the City took full advantage of this service, which the Lodge had put together.

Representatives from the various gun manufacturers conducted on site safety inspections and cleaned the weapons at no cost to our members. As a result of the inspections, a number of officers were informed of poten-

# Pension Update, By John Dineen

## **May Retirees**

At the May 26<sup>th</sup> Pension Board meeting, the Board approved seventy-one (71) retirements. The retirements were broken down by rank as fifty-seven (57) Officers below the rank of Sergeant, seven (7) Sergeants, six (6) Lieutenants and one (1) Exempt.

The average age of retirement for the month was fifty-seven (57) years with average service on the Department of thirty-one years and two months. This brings the total retirements for the year to 202 police officers.

At the May meeting the Board also approved six (6) refunds to Officers who left the Department voluntarily prior to retirement age.

# First Quarter Financial Info

During the first three months of the year the Market Value of the Fund decreased by about \$54 Million. This was the result of \$109 Million in pension distributions and expenses versus \$79 Million in member and City contributions, resulting in a \$30 Million shortfall along with a \$24 Million net investment loss.

As of January 1<sup>st</sup> the Pension Fund was 55% funded on a market value basis.

# F.O.P. Foundation Makes Award from the Steve Young Memorial Scholarship Program

Chuck Canterbury, National President of the Fraternal Order of Police, announced that the Steve Young Memorial Scholarship Program has awarded a scholarship to Maria Marquez of Darien, Illinois. "The F.O.P. sees the Steve Young Memorial Scholarship Program as part of its obligation to our extended law enforcement family," Canterbury said. "When Mrs. Marquez lost her husband in the line of duty, she became a single parent and a sole supporter of her family. This scholarship is designed to help families in these circumstances."

The Steve Young Memorial Scholarship Program is funded by a \$3 million grant from the U.S. Department of Labor and is administered by the National Fraternal Order of Police Foundation to assist the spouses of law enforcement officers killed in the line of duty. Officer Donald Marquez was an officer with the City of Chicago Police Department. On 19 March 2002, he was shot and killed while executing an arrest warrant. Officer Marquez is survived by his wife and four children, Donald, Jr., age 15, Alana, age 20, Carla, age 21, and Maria, age 31. The scholarship enables recipients to receive personalized career counseling at one of the more than 1,900 One Stop Career Centers, where they will develop an individual employment plan to help them reach their career goals. F.O.P. Grant Liaison Debbie Lakamp will accompany Mrs. Marquez to her initial visit at the Kane County Department of Employment and Education to meet with her Career One-Stop Case Manager. "By helping families like Maria's, we honor the memory of law enforcement officers like Officer Marquez who made the ultimate sacrifice in the line of duty," Canterbury said. "We hope that many more survivors will be able to benefit from the Steve Young Memorial Scholarship Grant Program."

# Financial Secretary's Report, By Tim Fallon

## Illinois Labor Relations Board

During the recent contract negotiations the City of Chicago passed an ordinance that created an intergovernmental agreement with the City, the Chicago Park District, and the McPier Authority. The purpose of the agreement was to transfer the authority to regulate traffic control on Park District property from the City to the other two agencies. The Lodge immediately filed an Unfair Labor Practice complaint with the Illinois Labor Relations Board. Administrative Law Judge Kazanjian ruled that the City violated the Illinois Public Labor Relations Act when they created this intergovernmental agreement. The City of Chicago appealed the ruling to the full Labor Board. On April 29, 2005 the Illinois Labor Relations Board issued the following ruling. Due to space constraints this is an abridged version of the ruling.

1. Cease and Desist from: (A) Enforcing or giving effect to the ordinance of September 5, 2003, and the intergovernmental agreements entered into pursuant to that ordinance. (B) Unilaterally changing terms and conditions of employment, in particular the performance of traffic control duties at Soldier Field. (C) Failing and refusing to bargain in good faith with the Fraternal Order of Police, Lodge 7 regarding the decision to subcontract to the Chicago Park District and McPier Authority traffic control duties at Soldier Field. (D) In any like or related manner, interfering with, restraining or coercing its employees in the exercise of the rights guaranteed in the Act.

2. Take the following affirmative action designed to effectuate the policies of the Act. (A) Rescind the ordinance of September 5, 2003, and the intergovernmental agreement entered into pursuant to the ordinance. Make whole any employees who have been adversely affected by the subcontracting of traffic control work at Soldier Field events. (C) Post at all places where notices to employees are ordinarily posted, copies of the notice attached hereto and marked addendum. (D) Notify the Board in writing, within 20 days from the date of this decision, of what steps the Respondent has taken to comply herewith.

The City has since filed a motion for a stay of the Labor Board's order, with the Labor Board, and will be appealing the case to the Appellate Court. The Lodge feels the chances of the Labor Board granting a stay, or the Appellate Court overturning the Labor Board's decision are very remote. In the City's motion for a stay they take the unbelievable position that this ruling "would work an unwarranted hardship on the City and would pose substantial questions of public safety." Apparently the City thinks that an event at Soldier Field or other similar venue, where there are upwards of 60,000 people in attendance, has no potential for theft, violent crimes, public intoxication, car accidents, or any other situation that cannot be handled by a traffic aide. The "question of public safety", is the City's refusal to use Chicago Police Officers at these functions. The contract proposal the Lodge submitted

in the recent negotiations is still on the table. Arbitrator Benn ordered the Lodge and the City to meet within 45 days of his decision, to discuss a new detail unit. We have sent the City a letter informing them we are ready to discuss this issue. have not yet received a response from the City as to when they are willing to meet. We have pointed out time and time again to the City that using civilian traffic aides at these types of events is unsafe. Civilian traffic aides cannot safely handle the amount of traffic, and crowds that attend these events. I believe that the City's strategy in this matter will eventually blow up in their face. At some point someone is going

to get hurt. When that happens it will be because there wasn't a Police Officer present to prevent the injury, or radio for medical assistance. The City will then find themselves in court, in front of a judge, explaining why they weren't negligent using civilian traffic aides instead of Police Officers to control thousands of people. There is one other point I would like to make. This is the first time a labor organization has been able to force the City to rescind an ordinance through the Labor Board. I think that is a very historic accomplishment, and shows that we not only enforce the contract, but also are vigilant of all legislation that affects our membership.

# Master Of Arts Degree In Police Psychology Program

### **MAP Program**

The Master of Arts in Police Psychology (MAP) Program is designed for field officers, supervisory personnel, command members and those interested in a career in law enforcement. The Program blends numerous areas within the discipline of psychology with pragmatic applications to patrol, operational and managerial concerns that arise daily in the field of law enforcement.

Note: Individuals who have successfully completed the ten week School of Police Staff and Command, Northwestern University will be granted 3 credit hours towards this degree by having the requirement of MPP Thesis waived.
