## President's Report, By Mark Donahue

#### **3% COLA INCREASE**

The Illinois General Assembly Veto Session ended on November 4th after proposing legislation and passing legislation that is very important to Law Enforcement in Illinois. Most important to us was the passage of HB 1009. This piece of legislation was sponsored by Kevin Joyce in the House and James DeLeo in the Senate and will entitle those born after 1949 and before 1 Jan 1955 to the 3% automatic cost of living increase in their pensions. This benefit will be retroactive to 1 Jan 2005 for those who have already retired this year and have attained the age of 55 as well. This benefit will apply to all members of our pension fund and not just the members of the Lodge. For the first time that I can recall, the passage of a pension bill was in doubt due to concerns not over the ability of the Pension Fund to afford it, but over concerns of Pension Fund investment history. Due to the cooperative efforts of the City and the Pension Fund, we were able to convince those who had those concerns that actions have been taken and will be taken in the future to address them.

#### **RACIAL PROFILING**

Although our Administrative Review Bill, HB1498 made it out of the House Rules Committee and was sent to the Executive Committee for a hearing, its arrival in that committee was not in a timely manner and will

likely be heard in the Spring session. It was a House Judiciary II hearing that took place during the veto session that sparked a great deal of interest in the law enforcement arena. That hearing was called to discuss the analysis of data that had been ordered collected relative to racial profiling across the state. Testimony on this issue surrounded the intent to identify to what extent actions of the police could be identified as racial profiling. Discussion at that time included that traffic stops in minority communities needed to be in excess of 30% more than in non-minority communities for there to be a definite conclusion that law enforcement was profiling minorities in those stops. This figure was discussed to address the issues of a greater police presence in minority communities which traditionally have a higher rate of criminal activity as well as car owners in these again traditionally lower economic areas who fail to properly maintain their vehicles in compliance of applicable state and local laws. The results of the data collection show that stops in minority communities were nowhere near the above mentioned 30% figures. A response to this fact from the representatives of the ACLU and other members of the Committee, during their testimony, was a disgusting display of disdain for our profession when they "re-enacted" what really happens during a

routine traffic stop. Their rendition of the police officer was anything but professional and verged on criminal. from the bad acting, some committee members suggested continuing collecting the data past the date in the current legislation [2007], expanding the collection to include all police stops and to also include criminal sanctions if violations are identified. There were some insightful members of the Committee who identified the discussion as a "waste of time", the information was referred to as "unqualified statistics", and that the analysis contained benchmarks that widely varied across the report. Contrary to a statement made by one member, no one has ever said racial profiling doesn't exist, it has always been the levels of frequency that have been challenged due to the pervasive intent to exacerbate the "Perception of Racial Profiling". That intent continues today as evidenced by the "reenactment" at the Committee Hearing.

#### 10-HOUR PILOT PROGRAM

We have received word from the Department that they are not going to continue nor expand the 10 hour pilot program that has been going on for the past year in Areas 1 and 5. The explanation for canceling the program has been less than satisfying and so a formal request has been tendered to the Superintendent for any

documentation upon which the decision was based. The Lodge has been attempting for ten years to address the problems with the sixth consecutive work day that most of us now work. Our position, based on your feedback, which was inclusive of documents submitted by those involved, shows that there is a benefit for the entire Chicago Police Department in continuing and expanding this successful program. The request was made to assist us and our membership in understanding the Department's position as well as establishing a basis for future negotiations.

## THE HUNDRED CLUB UPDATE

For those of you who don't know, the Hundred Club of Cook County is now the Hundred Club of Chicago. This organization has historically been at the forefront in addressing the needs of the families of those officers who have been killed in the line of duty. With the change of

name, they have also changed the ability of active sworn personnel to join the Hundred This action was in response to the many active Police and Fire personnel who have been precluded from assisting in the past. There is not another organization who has done more to help those families in their most trying times as the Hundred Club and if our members would like to assist in this work, please go to their web site at 100clubchicago.org.

## WHAT HAPPENED TO THE 10-HOUR DAYS?

On 09 November 2005, the Department sent out Department Notice 04-54. This notice was to inform the Department members that the pilot program for the 10-hour day was being "rescinded" as of 04 January 2006. There is no doubt in our minds that most of our members are wondering why the Superintendent would kill this successful program. Is the Superintendent aware that over 85% of our membership is dissatisfied with the six day work schedule that we have now? Has the Superintendent canceled the 10-hour day for Street Deputies, Personnel and Management and Labor Affairs? We think that the only way that the Superintendent can understand our frustration is for him to actually work the six-day workweek. I'm sure the Superintendent worked the six-day schedule sometime in his career, but if it's such an efficient schedule, why isn't he on it? This is what the members are asking us. Superintendent, it's very frustrating for an officer stuck working this schedule to have much of a home life. Imagine only hav-

ing two weekends off every two months and not being able to take time due the other weekends because there's a lack of manpower. Our officers go out on the streets everyday and do their jobs. It is very offensive that the given reason that you are dropping this program is because "it does nothing for the Department". We are the Department. We might be the grunts but we are the Department. We have worked with the Department since Day One to make this a successful program. We surveyed our mem-They are overwhelmingly happy with the program. Their morale is high and their family life is significantly better. The divorce rate on this job is higher then others and a big reason for it is the work schedule and the required court time. The Department has fought the Lodge on changing the schedule during negotiations. We have tried hard to show that there are positives for both sides on this program. The feedback that we have is that most of the Commanders in the pilot Districts are happy with the program. Superintendent, please

reconsider your decision as the men and women of this Department deserve better.

#### **FLU SHOT UPDATE**

On 10 November 2005, the Lodge had over 1000 members come down for a free flu shot. The Lodge has partnered with Advocate Medical Group and kicked off the free Health Fairs for our members. It was a huge success and starting in 2006, the Lodge will be having Health Risk Assessment tests at various locations throughout the City. More information about these tests will be coming in future newsletters.

#### WELLNESS BENEFIT UPDATE

The Lodge has filed a grievance and has demanded expedited arbitration in regards to the limitations that have been placed in the vision portion of the Wellness Benefit as well as Davis Vision administering the benefit. Hopefully we can get dates from the arbitrator in December and get this issue resolved soon.

#### UNIFORM RESALE

The Uniform Resale was held at the Hall on 19 Octo-

ber 05 and was a huge success. Officers from across the City were able to take advantage of the great deals at discounted prices. The Lodge also had a table set up and sold donated items. We raised \$1500.00, which will be donated to the Police Chaplains Ministry.

#### ZYLON VEST LAWSUIT

## Vice Presidents' Report Continued...

#### VESTS DN05-40

The Department, in response to the Zylon bulletproof vest issue, put out a Department Notice, #05-40, which advised officers that during the Winter Inspection their soft body armor would be inspected and no vest containing the fabric Zylon would be allowed to be worn by members of the Department. The Department Notice also advises officers that they may now wear the black vest cover as an outer garment. Officers who are considering replacing their vest have been calling the Lodge asking for recommendations of what the best vest is and what type to purchase. All of the vests which are manufactured are acceptable as long as they meet the Departments requirement of being at least a threat Level II and do not contain the fabric Zylon which is not found exclusively with any one vest manufacturer.

#### E.A.P. PROGRAM

The Holiday season is approaching and these festive times may cause some to become depersons pressed. During this time alcohol related problems arise along with higher rates of suicide and general feelings of hopelessness. If you are experiencing any of these problems you are not alone. The Employee Assistance Program (EAP) is available to members of the Chicago Police Department (active and retired) and their families The services of the EAP include Professional Counseling Service, Alcohol and Substance Abuse Unit and the Peer Support Program. The services of the EAP are free and confidential to those that use them. Just remember that you are not alone during a difficult time you are experiencing, that there is someone willing to listen. #### OUT OF DISTRICT DETAILS

On 14 Nov 05 the Lodge received one phone call complaining about midnight officers being sent from 016,017,018,019,023,024 and 008 to work in the 011<sup>th</sup> District. One beat car from each of these Districts was being reassigned daily. The complaint was that if these cars are in a different District then who is protecting their beats? The answer is no one. Last week a retiree who lives in the 016th District was one of seven houses on his block that had their garages burglarized on the midnight watch. What types of crime have occurred in the other Districts? What increases in crime were seen on the Beats that had their cars sent out of the District?

After a little bit of investigation it was revealed that this has been going on for a couple of months. If you are sent out of your assigned Area for a tour this is a contract violation. Not everyone knows the contract but if you are given an assignment and it doesn't seem right call the Lodge. Even on the midnights someone is available and can tell you if the assignment is allowed under the contract or if it is a violation and what steps have to be taken to correct the situation.

The Lodge notified M.L.A.S. of the practice on 15 Nov 05 and the practice was stopped. Again if it doesn't seem right that the Department gives you one of these assignments you are probably right, so take a minute and find out for sure.

Why was this practice started? We can only speculate that it was either because of the manpower shortage or an effort to hold down the homicide rate. All stops are pulled this time of year to keep the number of homicides below last year's numbers, especially when the Chicago Police Board reports homicides up in the 008<sup>th</sup> District by 43.4%, up 34.8% in the 025<sup>th</sup> District and up 116.7% in the 018th District. As of November 22nd, there are five homicides less than last year.

## THE MANPOWER SHORTAGE

Speaking of manpower we have seen complaints in the media from Alderman about manpower being short in Southside Districts and how the Department should not have disbanded Public Housing South. Officers from Public Housing South were assigned to Southside Districts when the unit was disbanded. Were they assigned to Districts that had an influx of residents from project buildings that were torn down? Before these officers were assigned how short was manpower in these Districts? We can't answer that but the problem probably goes to the overall shortage of manpower.

The Department's response in the media about the manpower shortage was that all Districts are approximately 10% short in manpower except for two Districts that are fully staffed one of those Districts being Grand Central. Well, a quick check shows that Grand Central is manned by 370 officers and 49 are currently detailed out of the District. So if a District that the Department says is fully manned is more than 10% down in manpower how short is a District that is admittedly down 10%.

A quick check of the manpower in the 022<sup>nd</sup> District shows there are 276 officers assigned and 58 are detailed out, even with rounding off it is over 20% short in manpower. We don't want anyone to conclude that the Department is using fuzzy math so we gave them the benefit of doubt and checked the 008th District. The 008th District has 330 officers assigned with 59 officers detailed out making the shortage over 15%.

We are under a deadline to get this newsletter out so we did not have enough time to review all 25 Districts but we are confident that these random samples will hold up citywide. As with most polls and statistical studies the end result would be the Districts that are admittedly down 10% in manpower will be more and the Districts that are up to full strength will be more than 10% down in manpower.

The manpower complaints are not new; "not enough policemen, rising crime," this has been the subject of most monthly C.A.P.S. meetings around the City for a couple of years now. The whole idea of C.A.P.S. is perception and the perception is that no one is listening so now the citizens are turning to the media with their complaints. The Department must search for a solution and insisting that manpower is adequate is not a solution. Maybe the solution is for the Department to create another Unit and name it the S.A.U. (the statistical analysis unit) to find out where the manpower is because it is not in the Districts.

Board Member. On 27 Oct 05, I was elected as a Pension Fund Trustee, representing all Active Officers below the rank of Sergeant. Here is an update on recent events.

On November 4, 2005, I traveled to Springfield to attend the Veto Session of the 94<sup>th</sup> General Assembly. I was present for the Senate Select Committee on Pensions And Investments Meeting chaired by Senator Iris Martinez (D). At that meeting, testimony was given by F.O.P. lobbyists and Representatives on Senate Bill 1693, which concerned Sheriffs Pension Benefits. 0930 that day, the Illinois Senate began their session. At 1030 hours, House Bill 1009, which gives Chicago Police Officers born before Jan 1, 1955 a 3% annual increase after they retire, was introduced by Senator James DeLeo (D), who sponsored the bill along with Senator Martinez and Representative Joyce. Senator DeLeo then responded to several inquiries concerning the bill from other Senators. Upon a call for a vote, the bill was passed overwhelmingly and now awaits the Governor's signature. If you come into contact with these or your own legislators, either on duty or off, let them know we appreciate their efforts.

On a personal note, I would like to thank all of those individuals who supported my efforts to be elected as your Pension Fund Trustee. I would particularly like to thank the entire F.O.P. Board of Directors and everyone who voted for me. It may have been only a few words of encouragement, advice or a pat on the back, never the less; I will never forget your kindness. those who voted for me, I promise to give my best effort to the task ahead of me. I will also endeavor to earn the trust of those who did not vote for me.

I also would like to express my sincere appreciation to my spouse of 26 years, Berni. Being a police wife for 17 years hasn't been easy and I couldn't have done it without her.

## The Professional Standards Conference

During the first week of November, I was invited to speak at the Professional Standards Conference in Toronto Canada, (Travel & Hotel paid by Toronto Police Dept). This conference was attended by over three hundred police officers from several different countries. This conference was for internal affairs officers. The topic I spoke on was the Sworn Affidavit Legislation. The speakers from the U.S. focused on how pattern and practice litigation and consent decrees have impacted their departments. Speaking on this subject was the Major in Charge of investigating profile complaints lodged against the New Jersey State Police. Also at this conference was the Commander of the Civil Rights Division of the Detroit Police who is responsible for the Detroit Police Department's compliance with their consent decree. This conference had many other prominent Police officials as speakers. The focus of these speakers was that once the Justice Department enters into a consent decree there is no chance of ever getting released from it.

The reason I am writing this is that when you are working the streets, the information on contact cards is entered into a database, and when the Feds have decided that they want to examine information on who the CPD is stopping, it is all at their fingertips. The speakers said the Justice Department does not want to hear that, "I work in this district so I only stop people of this race." My warning to you, brothers and sisters, is mix it up a little. Big Brother Is Watching.

## Recording Secretary's Report, By Sidney Davis

#### MILITARY RESERVISTS

As another Christmas is upon us, the war continues in Iraq. Police officers, along with their sons / daughters stationed overseas and stateside will miss yet another Christmas at home with family and friends. Please keep them in your daily prayers for a safe return home.

Police officers who are military reservists and have or will receive orders activiating them to active duty are asked to contact Sid Davis at the FOP (312-733-7776) or E-mail Sidney at sdavis@chgofopmail.org
There is important information you need to understand that will preserve your rights for pay and benefits.

Military retirees have a chance to enroll in the Survivor Benefit Plan (SBP) or increase their rate of participation during the SBP Open Enrollment Period (open season) from Oct 1, 2005

through Sep. 30, 2006. There is good news / bad news regarding this program. If you have retired from the military and have SBP or want to sign up for SBP, contact Sid Davis (FOP 312-733-7776) for information on the program.

#### SELL OR CARRY OVER

It's the end of the year again, and time to sell or carry over Baby Furlough (BFD) and Personal Days (Pdays).

Regarding baby furlough days: The amount of time you have on the job determines how many BFDs you receive. 1 year, but less than 5 years earns 3 BFDs, 5 years but less than 10 earns 4 BFDs, 10 years but less than 15 earns 5 BFDs and 15 years or more earns 6 BFDs.

Probationary Police Officers receive 3 BFD days the day they complete 12 months of probation. Officers who have an anniversary date during the year, which entitles you

to an additional BFD day, will receive the additional day on your anniversary date. At the end of the year, you may sell back all of your BFD days or any combination of them. You may carry over 4 BFD days for use in the next year.

Regarding personal days: Out of the 4 P-days you receive each year on January 1<sup>st</sup>, you may sell back up to 4 or carry over 4 for use in the next year.

Probationary Police Officers completing their 12<sup>th</sup> month of probation this month will receive 4 personal days. Rate of pay for sell back is computed as of April 1<sup>st</sup> the following year. Checks are also received on or around April 1<sup>st</sup>.

P-days or BFD days cannot be carried over for more then 1 year. For example, if you carry over 4 P-days from 2003 to 2004, you must use the carried over days by December 31, 2004 or you will lose them.

#### 2006 HOLIDAY EVENT CALENDAR

This month's issue of the F.O.P. Newsletter contains the 2006 Holiday/Event Calendar. A few changes have been made. DOG groups are listed as three digits. Members working a 10-hour work scheduled will use all three day off groups and members working a regular eight-hour day will use only the first two. ### Financial Secretary's Report, By Tim Fallon

Crime is down in Chicago. Actually crime is down all across the country, in all different categories. Most Police Departments like to take credit for the reduction in crime because of their innovative strategies towards law enforcement. While innovative strategies might play a part in crime reduction, there are usually several reasons for this occurrence. Since September 11th there has been a much improved coordination of Federal, State, and Municipal Law Enforcement agencies. Using technologies in the form of cameras and wiretaps have also assisted in crime reduction. Population shifts also affect crime. The city of New Orleans is a drastic example, prior to Hurricane Katrina crime was a big problem in New Orleans. When New Orleans rises again it will not be the same city, with the same problems. The same thing has occurred here in Chicago on a lesser scale. People move into neighborhoods and invest their time, efforts, and money to help create a safe community

to live in and raise a family. Gentrification as much or more than any new anti-crime strategy, helps reduce crime. But the real reason for a reduction in crime is because you are out there doing your job. Not because of doc meetings or caps meetings, it's because you are out there on the streets doing what you were trained to do, Law Enforcement. The Department will take credit for the job you do, however the Department's new strategy to fight crime seems to be the elimination of seniority bidding rights. There is definitive proof of this bold new approach to fighting crime. Last year the Department disbanded Public Housing South, a bid unit. The Superintendent then testified at a city budget committee hearing that he would create a new Targeted Response Unit (non-bid unit) to patrol Public Housing South. This matter is currently scheduled for arbitration. The Departcreated Operation Closed Market this strategy was to take officers that are

assigned to non-bid units, and have them sit in cars in front of designated "hot spots". The Lodge filed a grievance on Operation Closed Market and went to arbitration. The arbitrator ruled that under these unique conditions the Department did not violate the contract. Since that ruling the Department has used officers from Closed Market for other reasons such as guarding the Board of Trade, working at the airports, and most recently working at public schools. We used to have a School Patrol Unit (bid unit) that was disbanded by the Department. Now the Department is using officers from non-bid units to work in Public Schools. Patrolling Public Schools does not fit the unique conditions for which Closed Market was formed. We were told that the Department is in the process of creating midnight gang teams to be assigned to the We believe that this areas. violates Article 31.3 Exclusions for Steady Watch. The contract states "The employer

will not expand the excluded assignments (tact and gangs) or assign officers to the excluded assignments for the purpose of avoiding the provisions of this article." This has been the Department's entire crime fighting strategy, to expand units that are excluded from bidding for a steady watch. Just remember when you volunteer for these new units the Department can tell you to start work Monday at 0700, and at 1700 on Tuesday etc., with no penalty of overtime pay. Also remember the ten hour day, the pilot program was started to give our membership an option to the six day work week, and to give the Department options for coverage at shift changes. By all accounts, the program was working to the benefit of both our membership and the Department. The Department decided to end the ten hour day because "there was nothing in it for the Department." Remember those words when you volunteer to give up your seniority rights.

## Protect Yourself This Holiday Season, By Tanya Averett, (Internal Auditor of CPFCU)

The holiday season is here again!! The holidays are a time when family and friends come together to give thanks and show love. It is also a time when strangers choose to take advantage of your identity. ID theft is illegally capturing someone's personal data, such as, name, address, social security, and birth date. ID theft has been categorized into two sections: Account Takeover and Application Fraud.

Account Takeover happens when someone steals your credit, debit, and ATM card information to buy goods. The victims find out their personal information has been stolen when they receive their account statements.

Application Fraud happens when someone uses stolen information to open new accounts under a false address. Most victims do not find out their identity has been stolen until they have their credit report pulled.

## 5 Ways to Protect Your Identity:

- 1. Shred, with a cross shredder, any mail or financial papers with your personal information on it. Never recycle them.
- 2. Ask your credit card firm to cease delivery of "convenience checks."
- 3. Order a credit report a month or more before you make a big purchase or apply for credit, to be sure there are no surprises in your history.

- 4. Limit the number of credit cards you hold, and inspect your financial statements each month. Consumer rights quickly fade over time; the sooner you discover an identity theft incident, the better.
- 5. Delete emails that ask for your personal information and PIN numbers
