# President's Report, By Mark Donahue

### Police Officer Eric Solorio

On behalf of the entire Board of Directors I would like to extend sincere condolences to the family, friends and co-workers of Police Officer Eric Solorio. After having been seriously injured in an on duty traffic accident on January 17<sup>th</sup>, Eric succumbed to those injuries and passed on February 12<sup>th</sup>. Eric was a remarkable young man whose other career options were overshadowed by his desire to help people in the capacity of a Chicago Police Officer. In his short time on this job he exemplified the performance that is expected of all of us and by his actions caused a sense of pride for all who worked with and knew him and he will be sorely missed by all.

#### The Korshak Case

On February 14<sup>th</sup>, one of our in house attorneys, Paul Geiger, filed a petition in Court on behalf of our retired members challenging the premiums paid by retirees for their health care. The Korshak settlement established that the City would be responsible for at least 55% of retiree health care costs until July of 2005 and 50% of the total costs thereafter for those who retired with at least 20 years of service. What our retirees, and in fact all City of Chicago retirees, have been paying is the "anticipated costs" of health care since September of 2003. "actual costs" for almost 2.5 years since the settlement,

have been much less than the anticipated costs and the Lodge feels that the retirees are due a reimbursement.

Our interests in the actual costs of retiree health care became an issue during the past negotiations process when we were attempting to identify what the costs were for the City for our collective bargaining unit members. When we discovered a potential disparity between the costs and the premiums charged for retirees, we began to request the City's documents to either refute or corroborate our findings. When our requests went unanswered, we filed in Circuit Court on February 1, 2005 in an attempt to get the informa-That petition led the way for the one just filed in which we state the amount overpaid to the City for retiree health care is in the area of \$20,000,000.00. The City almost immediately countered that the figure is more in the area of \$15,000,000.00 that is owed to retirees. caused us concern that we may have underestimated our original amount. We have asked the court for: refunds of the overpaid amounts with interest; that the City account for all costs on an annual basis and reconcile same; and that the City pay for all court costs and attorney's fees.

Ironically, the City's response was that they were aware of the overcharges to retirees and that they were working on a plan to resolve the issue. The question then

is, after the filing in February of 2005 and the City's typical stalling antics in response to that petition, when the heck were they going to tell somebody? Without the "nudge" of this latest petition, they probably weren't going to say anything anytime soon. They have now sent out notices to retirees informing them that their premium payments beginning in March are being adjusted to reflect more closely the actual costs of the health care plan because as our petition reflects, if the current charges were to continue for the duration of the settlement, the overpayments could have reached over \$100,000,000.00. The Lodge feels confident that the City would not have spent the overpayments on any other program so that the issue of the repayment of the monies to the retirees will not be detrimental to the taxpayers in this town [theoretically of course].

#### **Vote In The Primaries**

At the direction of the Board of Directors, the Lodge sent out letters to all members reminding them of the responsibility to register and to vote in the upcoming elections. The Board felt that a direct appeal to the members would signify the level of importance that we feel this issue should take as most of what we are able to do in our professional lives in Law Enforcement is dictated by legislation that is passed on the National, State and Local levels. We need to be able to elect those we feel would best protect our interests.

campaign was done in concert with the other Unions representing employees here in the City of Chicago in an effort to collectively ensure those who are labor friendly get re-elected and we can't succeed in that unless our members vote.

#### **Endorsements**

After the interviews, the Committee proposed recommendations for the Board of Directors to consider. Their decisions for endorsements are posted in this newsletter and we ask that you give those endorsements the same serious consideration the Committee applied arriving at them. Please remember to vote in the primaries on March 21, 2006.

### Legislation

There has been little movement as vet on our state legislative agenda which posted here last month. Although we are having positive talks over the issue of Pension Portability, the abbreviated session could come into play as to our chances of getting anything passed. There are a lot of bills that we are following both in the House and Senate. At the forefront are those dealing again with racial profiling and the collection of Also at issue is the data. placement of video cameras in police cars. Although our position on the subject is that we do not object to it, the legislation that is proposed can have significant financial impact on municipalities that accept "State" money to buy them. The cost of equipping a car with a camera is miniscule when compared to the costs of maintenance and the storage and distribution of the recordings.

### Carry Concealed

The Carried Concealed issue for Chicago Retirees is now an issue of the past. I was informed last week that of the 650 applications that were held up being processed due to the City's position, all but about 50 have now been processed and many have completed the course of fire and have received their proper credentials. We received a great deal of assistance in resolving this situation from the Illinois Police Training and Standards Board. I am proud to announce that as of March 2<sup>nd</sup>, our F.O.P. State Lodge President Ted Street will be the

new Chairman of the Training Standards Board. Not only is this a personal honor for Ted but it is also a great recognition for the F.O.P. to have its president hold this position. Knowing the work ethic of Ted, congratulations

### **Expandable Baton**

On 8 February 2006, the Department issued Department Special Order 06-02, which will allow Officers to purchase and carry expandable batons. The authorized expandable baton is the ASP and the Monadnok brands. To carry an approved expandable baton Officers must attend a four (4) hour training course at the

Training Academy. Officers who were previously trained and authorized to carry the expandable baton during the pilot program are still authorized to carry the expandable baton with which they were trained. Officers who become involved in a use of force incident involving the expandable baton will complete a Tactical Response Report (TRR). Officers completing the TRR should complete boxes 38 and 40 checking other and inserting the words, Expandable Baton. Officers, please also continue to write the disclaimer in Box 40 of the TRR.

# Injuries On-Duty and Duty Disability

Every officer who is injured on-duty starts out with a trip to the emergency room for treatment with follow-up referrals through the Medical Services Section. The officer is given referrals for follow up treatment, therapy and surgery (if necessary).

Contractually, an officer is entitled to 365 days of paid time off to recover from each injury on-duty. These 365 days are limited to that 1 vear of recovery time in an officer's career. Should an officer use all 365 days, he/she goes into a no pay status pending a hearing at the Pension Board. The officer at this time goes to the Pension Board and receives an affidavit (that the officer fills out) describing the circumstances of his/her injury on-duty. The Lodge attorney will assist the officer with this affidavit. The officer then turns the affidavit into

the Pension Board.

While an officer is waiting for the final determination of benefits by the Pension Board, they are required contribute the same amount as active officers for health care benefits. The Pension Board then starts the process where the officer is sent to the Pension Board doctor along with a copy of his/her medical records. The doctor then makes a decision based upon a physical exam and the medical records from the Medical Services Section, whether or not he believes the officer is disabled or able to return to work.

The Pension Board, which normally meets on the 4<sup>th</sup> Thursday of the month, then takes testimony from their doctor. If the doctor believes that the officer is incapable of returning to work, the officer is granted 50% of his/her salary pending a full hearing before the board to determine if the officer is granted the 75% Duty Disability. If the doctor believes that the officer is capable of returning to work, then nothing is awarded until the officer's full hearing before the board. There are occasions where the board's doctor has to send the officer to a specialist to determine capability of duty.

Once the officer is granted Duty Disability his benefits include 75% of his salary, tax free, which is determined by the salary rate on the date of the award. The City agrees to pay all hospital, medical and prescription costs for an officer who is on a leave of absence for Duty Disability or occupational disability purposes, all at no cost to the em-

ployee. The employer also shall make pension contributions on behalf of the employee as if he had remained in active service. Further, while on disability, if the officer needs any treatment for his/her IOD, he gets a referral from the Medical Services Section and continues his care

for as long as necessary. The officer is represented at the Pension Board by an F.O.P. attorney free of charge for the duty disability hearing.

### **Update on Wellness Vision Arbitration**

The City put on their side of the case in February and, by this time, the briefs

have been submitted to the arbitrator. We are patiently waiting for his decision that we hope to have by the end of this month. Save any receipts that you have spent on vision for 2006.

# Work Schedule Committee Report, By Kevin Graham, Chairman

The Work Schedule Committee has been working hard, first to expand the 10-hour day and identify those officers who would like to work this compressed schedule, as well as those who would prefer another choice.

Since the Department has stopped the pilot program, the Work Schedule Committee will continue its work to find a better schedule than 6-2 with which the majority of our members are unhappy. The Committee is determined to collect as much members' input into the work schedule as possible. As of March 1, the Work Schedule Committee will be accepting reasonable suggestions from our members.

There are hundred of different schedules used by other agencies.

If you would like to submit a schedule for the Committee to consider, we need the following data:

- Total annual hours. The schedule should be approximately 2080 hours in one year, according to the Fair Labor Standards Act.
- 2. Appropriate: The schedule must be FAIR to all members.
- 3. Supporting evidence: Include any supporting evidence of the proposed schedule's workability, benefits to officers and/or the Department (including

copies of the schedules that other departments work) and all concerns with new arrangements both obvious and not underlying.

- Equipment: On previous occasions, the CPD has told us that it does not want to purchase additional vehicles or radios.
- 5. Documentation: Most importantly, provide supporting evidence that is published, either a study, (medical, academic or otherwise) a new report or other article addressing the effects of police officers' working long hours, thus spending little time with their families. Be sure sources and dates of

publication are included. All suggestions should be sent to the F.O.P. Work Schedule Committee, Unit 541 via Police Mail before 01 June 2006. The Committee will consider all suggestions, no matter how numerous. The Committee realizes this is a large Police Department with many perspectives. It is probable that one schedule will not make everyone happy, but we are committed to doing our best. The City is happy with the current schedule. If you are working a 6-2 schedule and are satisfied with that schedule let us know.

### Recognized Watch Vacancies

Under Section 31.5 of the contract, Filling Of Vacancies, if and when the employer decides to fill a recognized vacancy by bid, such vacancy to be bid shall be posted on the seventh calendar day of the 3rd period (March 8th), the sixth period (May 31st) and the ninth period (23rd). The posting shall remain up for seven calendar days. The vacancy shall be filled by the most senior qualified officer. If no such qualified officer within the unit bids for such vacancy, the Employer may fill the watch vacancy by reverse seniority.

There has been a schedule change for the 2006 F.O.P. Fishing Tournament. The original date had been set for June 1, 2006. The new date is May 31, 2006. The change was made due to a scheduling conflict with other events. We hope the change will not be an inconvenience for our fishing members. This issue of the

# Financial Secretary's Report, By Tim Fallon

#### **Arbitration Decision**

The Lodge received a winning arbitration decision from Arbitrator Peter Meyers in February. This case involved an officer from SOS assigned to Comiskey Park area during a night game. During roll call the officer involved remembered that he left his star and ID at home. The officer notified his immediate sergeant that he did not have his star, and requested permission to go home and retrieve the star. This is where the story differs from the officer and the sergeant. The officer states that the sergeant gave him permission to go home to retrieve the star. The officer then went home, retrieved the star, and stopped for lunch in the vicinity of his house. While having lunch the officer's car was observed by an Exempt Rank member at a restaurant. The Exempt Rank knew by the beat tag that the car was as-

signed to the Comiskey Park neighborhood for the night. The Exempt Rank contacted the officer's Commander to inquire of the officer's status. According to the Commander the officer was supposed to be at Comiskey Park. A CR# was obtained, and during the investigation the officer's sergeant gave a statement that basically said he never gave the officer permission to go home to retrieve the star. As a result of the CR investigation the officer received and served a 10-day suspension. The Lodge then proceeded with the case to arbitration. In the arbitration the Lodge and the department both put on witnesses relative to the incident. All the witnesses testified in keeping with their reports submitted to the CR investigation.

At this point the case boils down to the officer's word against the sergeant's. This is not a strong position to be in. We would have to convince the arbitrator that the sergeant was not telling the truth, merely because the officer's story was in conflict with the sergeant. Absent any other corroborating evidence, the arbitrator would have probably found for the department and upheld the grievance. However there was another factor in this case, the CR investigation.

While preparing for arbitration we checked through the CR file and found that the investigation was done improperly. The first of several department errors in the CR investigation was that there was no CR initiation report. The department then obtained a report from the officer before getting reports from the supervisors involved. The supervisors involved were allowed to read the officer's report prior to submitting their The department then added another allegation to the investigation, and did not allow the officer to respond to the allegation. The Lodge told the arbitrator that the issue of an

improper CR investigation and denial of the officer's due process must be addressed before making a determination on the CR itself. The Arbitrator agreed with the Lodge in rendering his decision. In the decision the Arbitrator stated, "The impact of requiring the accused to give a statement first, and then making that statement available to witnesses as they prepare their own statements, is staggering." Arbitrator Meyers also stated "All of these departures from the dictates of General Order 93-03 must be viewed as more than innocuous procedural errors. Each of these problems could have worked to deprive the Grievant of a fair investigation and the benefit of his due process rights." What Arbitrator Meyers told the department in his decision is you made the rules you have to obey them. The grievance was granted, and the officer received 10 days of pay.


