Negotiation Update

On June 6th the Lodge and City met for the first time in our hall to discuss the ground rules and introduce the Negotiating Teams to each other. At that meeting, the Lodge tendered to the City about 40 proposals that were the culmination of over a year's worth of recommendations obtained from the membership and several meetings with our Negotiating Team who were responsible for paring down the volume of recommendations while at the same time prioritizing those recommendations that they felt had the most impact to our members. These were then approved by the Board of Directors. After presenting them to the City, the Lodge posted them the same day on our web site.

Although the City had no proposals to tender to us, an agreement was reached that we again would not negotiate in the press.

Since posting our proposals on our web site, members have contacted the Lodge offering opinions and suggestions about the proposals. We welcome all comments and suggestions as we go through the process. Please keep in mind that we do send all 50 Aldermen a copy of our newsletter and we know that the news media reads our web site. If you feel the Lodge isn't posting enough information here relative to the progress, or lack thereof, of the negotiations, it's because of the agreement. We mony was based on several are able to speak more freely at General Membership and Board of Director's Meetings on these issues and all members are entitled to be heard.

City Council Meeting

The press did a pretty good job of covering what happened at the City Council hearing on the OPS proposal. Four Aldermen used a Council procedure, which allows any two of them to postpone a vote on a recommendation until the next Council Meet-The feeling by these ing. Aldermen is that the proposal to revamp OPS by the Mayor isn't going far enough in addressing the "perception" that has been enhanced by recent events. Special interest law groups and certain members of academia who settle law suits and publish articles over issues they take with OPS agree with these Aldermen. It is anticipated that the Mayor's proposal will pass at the next council meeting. Then it will be up to the City to deal with the issues that are contained in it that conflict with our contract.

At the Police and Fire Committee that preceded the Council Meeting, several of those testifying should have been embarrassed by their presentation. One presenter blamed the problems with OPS on certain provisions of our contract, but argued with the Committee Chair when he was told that the Sworn Affidavit issue was legislated in Springfield. Another's testi-

statistics that anyone could have successfully refuted without having a degree. This will be an issue of discussion at the negotiating table and the City probably shouldn't be discussing it in the press.

Legislation Updates

Last month I wrote about three pension bills that had passed out of the House Committee in Springfield on May 24th. After passing out they went to the House for further consideration. This is where the statement "anything can happen in Springfield" takes over. Keep in mind that the Legislative Session was already extended and that as of June 1st, passage of any bills would need a $3/5^{\text{th}}$ majority.

In the House on May 29th, SB1380, which had passed out of the Senate to the House and addressed a pension issue, was amended to include the language of all three of our issues. This newly revised bill had to go back to Committee for approval and was voted out of the House on May 30th. When it arrived in the Senate for a concurrence vote on May 31st, it went to committees and was voted to pass by 33 Senate members. Had this been voted on after that day it would have needed 36 votes to pass. It's now on the way to the Governor's desk and upon his signature: widows will be able to remarry without losing their pensions; widows will be able (Continued on page 2)

to appeal to the Pension Board if they haven't been married for a year when their spouse dies; and physically or mentally handicapped dependents can now keep their pensions regardless of their age.

On the issue of Pension Portability, our last contact with the City has set the stage for a meeting between the Lodge and the City Budget Office. In that meeting we will once again attempt to show them that, as their own actuarial report explains, there is no cost to the City or the Fund based on the passage of this bill.

In Washington there are now 309 co-sponsors to the Social Security Fairness Act in the House and 31 in the Senate. Our National Office will be working this Bill and our other Labor Bills until Congress recesses this month.

> Carrasquillo Parole Hearing

On June 20th, there was a parole hearing for the killer of Police Officer Terry Loftus who was murdered in 1976. This case gained some notoriety in 2002 when it was brought out that several politicians had endorsed the release of Ronnie "Mad Dog" Carrasquillo. At his last parole hearing, this killer obtained 6 votes in favor of paroling him. Recently, the States Attorney's office has let us know that there seems to be a sway towards parole by the Board for many long sentence convicts. Many of these convicts have killed Police Officers. The Lodge has made the decision to get more involved than writing a letter of protest in these cases and so we are going to pass petitions, contact individuals who may be interested in appearing and testify on behalf of our membership for the denial of parole. Frank DiMaria presented the Hearing

Officer with about 2,300 signatures requesting denial of parole, and I and several of Terry's partner's, a State's Attorney who worked on the case and the Superintendent's representative gave oral testimony. After we left the building and were making small talk, one of his partners asked if what we did really will mean anything or are we just spinning our wheels. It was a good question. We believe that what we do on a daily basis makes a difference and so it is with this situation as well. Although it would be difficult to factually state whether or not our actions make a difference, how would we ever know if we didn't try and how much would we blame ourselves if they let the killer go free when we did nothing?

Please, if you see a petition to keep a cop killer in prison, sign it. If you can, come to the hearings, a show of support is always helpful. As one who testified said, all that is between the dead Policeman and justice are the prison walls where the killers should complete their sentences. It is their only justice and the Parole Board and the Police need to share in partnership in helping to keep society safe and giving the Police justice by keeping the killers where they belong.

Limited Duty News

The City was going to implement a policy starting June 1st, 2007 that would eliminate any members being able to go into a limited duty status. Members that were already on limited duty could remain on limited duty until they retire or come back full duty, but no new members would be able to go on non-IOD limited duty. The City explained to the Lodge at these meetings that the non-IOD limited duty has more than doubled in the last six years and that there is not enough limited duty spots. The Lodge continues to meet with the City regarding non-IOD limited duty status and will keep our membership informed of any changes.

Retiree Dental And Vision Plans

The new Dental and Vision Plans for retirees went into effect on June 1st, 2007. There were some minor problems, as with any new plan, the first couple of weeks. Everyone should have gotten his/her dental cards in the mail by now. You will not be receiving cards for the vision plan. The pension board will be deducting the premiums from annuitants' checks that come in July for the months of June, July and August. We have almost 1400 members who have signed up for the dental plan and almost 1100 members who have signed up for the vision. Members can continue to sign up until Septem-

ber 1st, 2007. **Injury On-Duty Bills**

We receive many calls regarding the bills that are incurred as a result of an Injury on Duty. Whenever medical treatment is received, the medical providers will start sending bills to the officer for services rendered. The payment for all I.O.D. related bills becomes the responsibility of the City of Chicago. In order to get the bills paid, the officer will need to send a copy of the bill to the I.O.D. Unit at the Medical Services Section, located at 3510 S. Michigan.

After the I.O.D. Unit receives the bills, they are compiled and audited in order to substantiate payment. Once this part of the process is completed, the bills are forwarded to the City of Chicago-Committee on Finance. In turn, the Committee on Finance submits the bills to the City Council for their approval to pay. Finally a check is rendered to the provider.

Each time an officer receives another notice of the bill; he/she should again forward it to the I.O.D. Unit at 3510 S. Michigan. In the event that the officer receives a collection notice for non-payment of the bill, the officer should contact the Committee on Finance as soon as possible to determine the status of the claim. Parole Hearings For A Cop Killer

Police Officer Terrance Loftus, Star #5701, was on his way home after completing his tour of duty on 10 October 76 when he observed a group of gang members beating a person on the street at Fullerton and Central Park. Officer Loftus, instead of driving past and calling 911 from a safe distance, chose to take immediate police action and stopped his auto. While he was attempting to disperse these gang members, an on duty Sqaudrol observed the disturbance and recognized Officer Loftus all ready on the scene. They immediately put in a call for more help, 10-1, and these uniformed officers stopped.

A gang party was being held across the street from the beating and gang members, after learning the police were interfering with gang business, rushed outside. One of the party goers who went outside was Ronnie Carrasquillo. A self-admitted gang member himself, who was already armed with a handgun, asked for and was given a more powerful and accurate handgun. Carrasquillo held the weapon with both hands, steadied himself against a parked auto and took aim into the street at the police officers. Carrasquillo was warned by his fellow gang members not to shoot, that these were police officers in the street, but he did not take their advice and fired his handgun four (4) times. Officer Loftus was struck in the face by one of the bullets and he fell onto the street.

Officer Loftus was taken to a nearby hospital where he died of his wounds on 12 October 76. Carrasquillo fled the scene and went into hiding, bragging to his friends that he had killed a "pig". An intensive search was conducted and Carrasquillo was arrested a few days later. Carrasquillo was charged, a bench trial was held in court and he was found guilty of the murder of Chicago Police Officer Terrance Loftus. Judge Frank Wilson sentenced Carrasquillo to 200-600 years in IDOC on 17 January 78.

The Lodge was notified that Carrasquillo's case was going to be scheduled for a hearing to consider early release on 20 June 07 at 26th & California before a member of the Illinois Prison Review Board. The Lodge, upon learning that this hearing was to be held in 10 days, began a petition drive to obtain signatures objecting to this convicted cop killer's early release. The Lodge received, in one (1) week time, returned petitions with signatures from 2,353 Citizens and Police Officers requesting that Carrasquillo's request for early release be denied by the Illinois Prisoner Review Board.

On 20 June 07, the hearing was held at 26th & California, 13th Floor and was attended by the President of the Lodge, the ASA, a representative for Superintendent Cline and myself. Also in attendance were five (5) friends and previous coworkers of Officer Loftus, four of whom are now retired. Letters of objection and state-

ments which were made by those present along with copies of the signed petitions and letters were entered into the record demanding that the Illinois Prisoner Review Board not grant early release to this convicted murderer. The hearing was video taped for future review by the full board and was presided over by one (1) Illinois Prisoner Review Board member. There was no decision made at this hearing regarding early release.

Another hearing is scheduled for 19 July 07 at Lawrence Prison where the case will be presented to one (1) member of the board for early release of Carrasquillo and his group of supporters will be present. This group of supporters claims that he is a model prisoner and deserves a second chance. These supporters say he should be released from prison and the board should have mercy for this convicted murderer and 30 years is enough punishment for killing a Police Officer

PO Terrance Loftus, #5701, was never given a second chance when he was shot by Carrasquillo on 10 October 76. There was no mercy shown PO Loftus as this cowardly murderer fired his handgun to commit gang violence. There was no mercy shown to the other two officers who were in the street who were in full uniform attempting to do their duty of Serving and Protecting the Citizens of the City of Chicago. Judge Wilson sentenced Carrasquillo and justice has been administered and handed down. This self admitted gang member wants to be released from prison, but he will not admit his own guilt to the crime he has committed nor has he shown any remorse for taking the life of PO Terrance Loftus at the age of 36. This selfish murderer can only say he was young and wants to come out of prison at the age of 48 so he may enjoy the remainder of his life.

The Illinois Prisoner Review Board will convene at an open meeting to make their decision regarding this matter in the beginning of PO Terrance August. Loftus, #5701, was a Son, Husband and Dear Friend to many and was taken from us as he made the supreme sacrifice on 12 October 76. We can only hope that the Illinois Prisoner Review Board will, with good conscience, fully review this case on its true merits, not by the influence of outside support groups of a murderer. We can only hope that the Illinois Prisoner Review Board will deny parole for a convicted cop killer and Ronnie Carrasquillo will continue to serve the remainder of his term in prison.

We will never forget!

Health & Insurance Committee Report, By Ed King, Chairman

Vision & Dental Insurance Plan Update

I wanted to take a few minutes to update everyone on the progress of the Vision and Dental Insurance Programs that were recently negotiated by the Lodge, through United Health Care and Spectera United Health Group, for the benefit of our retired officers, their families, widows and widowers. I also wanted to make those who have already enrolled or are thinking of enrolling aware of a few adjustments that have been made, as well as answer a few questions that have come up.

To date, over twenty five percent of our retired members have already enrolled in the vision plan, the dental plan or both. Although it was the intent of the Committee and the Lodge to make enrollment as easy as possible, there have been a few glitches, but none that have interrupted coverage. Thanks to our excellent office staff, many of these problems were recognized and corrected before becoming catastrophic and I am confident that just about all of them have been resolved. I also wish to thank all of the participants for your patience and understanding during this transition period.

For those qualified who have not yet enrolled applications will be accepted through mid August for the 2007-2008 calendar years. After that, the next chance to enroll will be for the 2008-2009 calendar years. This open enrollment period will begin in July of 2008 with an effective date of 01 September 2008.

Those of you who have already enrolled will notice a

triple deduction from your July 2007 pension contribution. The reason for this was due to an electronic deduction problem between the insurance companies and the Northern Trust Bank. This has since been corrected, so future deductions will be on a monthly basis as planned. This three-month premium will be for the months of June, July and August. Both Spectera and United Healthcare will be sending a written notice to all participants explaining this one time triple deduction in greater detail.

For Dental coverage, identification cards were sent out in the mail on June 15th. If you have not received your card, please contact the dental provider, United Health Care at 800-996-7507 and a representative will assist you in getting an ID card.

Those that have the Vision coverage will not receive an ID

card for it is not needed. Simply tell the provider rendering services that you are with Spectera United Health Group and with Chicago FOP. Then give them your ID number (SS number). The provider will contact Spectera, 800-980-2958 in order to obtain the necessary eligibility information needed for treatment and billing.

As always, the Committee remains dedicated to addressing the needs of our members both active and retired. Just as we deal with changes in our profession, the cooperation and patience of everyone involved has made this much needed benefit a reality. We welcome any constructive comments.

The Department has opened up the Movie Detail to all sworn, FULL DUTY members below the rank of Lieutenant. The Commander of Special Events will act as the liaison to film production companies that hire our members. Since we have no contract with the film production companies, participants in this program will be considered "at will" employees of the production companies. However it is the position of the Lodge that since our members are working in a Department sanctioned, secondary employment position, all of the job protection provisions of our contract, as they relate to the City and the Department, will apply, such as injury on duty and duty disability. Salary and hours are determined by the film production company.

The rate of pay for this secondary employment is \$30.00 per hour, and \$45.00 per hour for overtime. Officers will be paid directly from the film production company, not the Department. You must fill out the proper tax forms in order to get paid; this means you have to give your social security number to the film production company. Again, we have no contract with the film production company and that means the film production company has the right to offer or deny employment opportu-

Judging by the customers and cars that were passing him by, Jim guessed they were thinking the same thing as he. So Jim got out, and walked over to see what the trouble was. "Is there anything I can do?" Jim asked. It was then that Jim noticed he wasn't able to speak, and the young man was struggling with the wheelchair. "Is there someone I can call for you? Jim asked. The young man still couldn't give Jim any indication.
