President's Report, By Mark Donahue

Contract Negotiations

There has been progress in negotiations with the City. All subcommittees have now met at least once with the City to discuss the issues that we have brought forward. At this time nothing has been agreed to on those issues and more meetings are scheduled. As in the past, we do not intend on signing off on any individual issues. The contract proposals that we have presented are a package. That package will become complete when we are given the City's proposals to consider and once that process is complete, that package will be the one that will go to the membership or to an arbitrator. We have no intention of negotiating forever or of giving the City an endless timeline in making decisions. As soon as we get the City's proposals, we will place them on our web site.

Prisoner Review Board

On November 15th, the Illinois Prisoner Review Board met to consider paroling the man convicted of the murder of Police Officer Ken Kaner in 1970. As we have stated in the past, the Cook County State's Attorney's Office has requested that the FOP get more involved in these hearings. Traditionally, a letter of request to deny parole for cop killers was sent to the Board chairman. Due to the change in philosophy of certain members of the Board, they now feel that those prisoners who have received extensive sentences for their crimes should be addressed more favorably for parole consideration. Unfortunately they fail to realize that many of these killers who are now coming up for parole, received those sentences at a time when the death penalty was not allowed in the state and the extensive sentence was to ensure that they never see the outside of a prison facility for the rest of their lives. We know this because many of the States Attorneys and Judges that handled the cases have said so in their briefs. As for the case of Officer Kaner's killer, there were detailed pleas both for and against release, but because of the solid presence of his family along with the support for denial that had been undertaken by the FOP, the killer's parole was denied by a vote of 9 to 3. This is actually an increase of support for denial than in past years. The tide apparently can changed so when you see a petition for denial of parole especially for a cop killer, please take the time to fill it

Change of Course

On May 5th, 2006, an off duty officer was arrested for DUI in the City of Chicago. While being processed for the arrest, the off duty officer refused to submit to a breathalyzer for the criminal proceedings. A short while later, IAD personnel ordered the officer to submit to a breathalyzer for the administrative

portion of the Department's investigation. After being given the direct order, the officer complied. These results have been used in the Administrative process for discipline, but never have they been used for the criminal prosecution, due to the duress of being given an order under the Garrity Rule. In this case, the State's Attorney attempted to use the administrative blow for the DUI charge. The Lodge's attorney filed a brief on behalf of the officer and argued that the results of the breath test could not be used at the criminal trial. The Lodge outlined its argument in great detail and on November 15th, the Judge ruled in our favor that the State could not use the results of the breath test. The State announced that it will appeal the decision and the Lodge will again take the arguments to the Appellate Court. We'll keep you posted on this very serious case before the court.

IPRA = OPS

There has been much in the media and on the bath-room walls relative to the new OPS, the Independent Police Review Authority, and their duties and responsibilities at police involved shootings. Unfortunately 90% of it has been wrong. The IPRA does not conduct police investigations because they are not the police. They are not conducting interrogations of our members at the scenes. They

can still only ask questions at the round table through an identified questioner. The protections that we have in our contract are still in place and the order addressing police involved shootings is still the same. The media, and even some of our members who have felt inclined to involve themselves in spreading misinformation, help to exploit the negative perceptions of those that are not our friends. Unfortunately, lies can race halfway around the world in the same time it takes truth to tie his running shoes.

Retiree Health Care

The Lodge has recently received the numbers on the costs for Retiree Health Insurance from the City for 2006. We will have an actuary examine the figures and reconcile

the amounts for any potential overcharges that may have occurred. This will be the third time the Lodge has undertaken this process on behalf of the City's retirees and we anticipate doing so for the remaining years of the Korshak decision.

New Feature In Newsletter

For Active and Retired members, the Lodge will include Health Tips starting with this Newsletter from certified personal trainer Joe Cullen. Joe is not looking for new customers, but wants to assist active and retired members of the Department with his offerings of advice.

2008 Handbook Packages

Handbooks, ID's and stickers for 2008 are in the mail for active officers. The packages

for Retired Members will be sent out in mid-December once we have all the information from the renewal forms.

FOP Board Elections

It's election time again. Anyone interested in running for an office on the FOP Board of Directors needs to be at the General Meeting on December 18th at 1200 hrs. The meeting will be turned over to the Election Committee to oversee the process of signing for Nomination Petitions. The Committee has decided that the petitions need to be turned into the Lodge by the close of business on Friday, December 28th. The ballots are scheduled to go out in February with the counting to occur on March 14th. Those who have held positions in the Lodge

realize what a serious responsibility and commitment it is in representing our members. If you can make that commitment please consider taking an active role in ensuring the safety and security of our members and their families by running for office.

First Vice-President's Report, By Bill Dougherty

Flexible Spending Account Reminder

If you have money left in your 2007 Flexible Spending Account, keep in mind that you have until March 15, 2008 to submit your claims. If you don't use all the money left over in your account by March 15, 2008 you will lose it.

Notify BMO of Any Status Change

If you are getting married, divorced, adopting a child or expecting the birth of a child, keep in mind that you must notify the Benefits Management Office of these events. You have 30 days from the date of the family status change to notify the BMO. To change your benefits as a result of a family status change, you must submit a completed enrollment form and provide proper documentation. If your

enrollment form indicating your request for a change in coverage is not submitted within 30 days you won't be able to make the change until the next open enrollment period.

Subrogation

Whenever medical treatment resulting from an accident is submitted to Blue Cross/ Blue Shield for payment from a medical provider, it prompts a letter to the officer from the law firm of Kukankos and Coughlin, Cook. This letter serves as notification from the City that they are invoking subrogation rights. This means that the City can recover any monies that they paid for medical treatment. In addition to the letter, a questionnaire requesting certain information regarding the accident such as:

• Whether or not you have

retained an attorney to sue.

- If an insurance company or another party is responsible for payment.
- Whether there is any other means of recovery.

This questionnaire must be filled out and returned or payment of benefits may be withheld.

Injury On-Duty Referrals

When you are injured onduty or have a recurrence of a prior injury on-duty, you must request a referral to a doctor from the Medical Services Section. You should be shown the list of doctors by your nurse and allowed to pick your doctor. If your doctor decides that he needs to schedule another appointment or needs additional tests done, you must contact the Medical Services Section and

get a referral for these services. You need a referral for each and every time that you go to the doctor. If you don't have a referral from the Medical Services Section the Committee on Finance won't pay your bill.

Medical Mediation

Once a month the Lodge meets with the City to discuss medical grievances that were filed the prior month. Grievances that we are unable to resolve at mediation go forward to the Grievance Committee. The Committee reviews the cases and decides to demand arbitration, withdraw the grievance or accept an offer on a grievance.

On November 16, 2007 the Lodge met with the City to discuss 14 medical grievances that were recently filed. In two of the cases the

grievance was granted, three of the cases settled, two cases we demanded arbitration, one case went to the grievance committee and six of the cases needed to be followed up for next month.

Weapons Discharge Incidents

Officers, if you are involved in a Weapons Discharge Incident, you should notify the Lodge immediately. The Lodge has office hours Monday thru Thursday, 0800 hrs until 1800 hrs and Friday 0800 until 1600 hrs. A Field Rep is available on call after business hours 7 days a week to assist with these types of incidents. For Police involved shootings, the Field Rep on call will respond to the scene and then to the Area assisting the involved officer throughout the process.

Officers, you are required to cooperate with the investigation and obey the Laws of the State of Illinois along with the Chicago Police De-

partment Rules, Directives and General Orders. You should be aware that in the event of a weapons discharge incident you should not be interviewed by representatives of an outside department agency (IPRA/OPS) on the scene or at the Area where the incident is being investigated. You are entitled to representation per the Contract and the Officers Bill of Rights if you are required to give a statement to anyone from an outside department agency (IPRA/OPS). Officers, you should always know the name and rank of those you speak with at a Weapons Discharge Incident. Don't give away your rights to anyone just for the asking.

Vest Safety Days

The Lodge will be hosting a Vest Safety Day at the Hall on

14 February 08 from 0900 hrs until 1700 hrs. There will be Representatives from the various Soft Body Armor Manufacturers who will display the latest models of their products for our members. Please mark your calendar and come down to the Hall to take advantage of another benefit the Lodge has provided for its members.

Employee Assistance Program (EAP)

The Holiday Season here and these festive times may also cause some persons to become depressed. During this time alcohol related problems arise, along with higher rates of suicide and general feelings of hopelessness. The Employee Assistance Program (EAP) is available to members of the Chicago Police Department (active and retired) and

Third Vice-President's Report, By Greg Bella

Tracking Number

When a citizen's complaint against an officer is received, IPRA issues a tracking number. The tracking number can be investigated up to the point where the officer is to be interviewed or required to write a report. At this time an affidavit is required for the investigation to go any further. If an affidavit is not obtained the tracking number is deleted and the complaint goes into cyber space. If an affidavit is obtained then the tracking number becomes the C.R. number.

If the affidavit is obtained then the investigation can continue. A copy of the signed affidavit must be shown to the officer before the officer makes any statement or writes a report. If a supervisor is requesting a statement from you and there is no copy of the affidavit the supervisor can call the appropriate agency (IAD/IPRA) and they will fax a copy of the affidavit. Once you are shown a copy of the affidavit you must write the report or give a

statement. If any question arises over whether or not an affidavit has been obtained call the Lodge before you write your report.

Police Shootings

Once again the community activists are up in arms over police related shootings. The activists should be preaching the law. It is against the law to own or carry a firearm; it is against the law to point a firearm at another person. It is against the law to shoot at any person and against the law to wound or kill another person.

What they should be preaching is the consequence of possessing a firearm, a jail sentence if you shoot someone and possible death if you point the weapon at a police officer. To the reporters who love to fuel the fire, when are you going to ask real questions? Every person shot by the police was just starting to turn his life around, putting their terrible past behind them. The question is why did he have a gun? Why did he point the gun at the police?

What we don't need is these so called activists being Monday morning quarterbacks because if you were in the same circumstances the outcome would be the same.

A recent study shows that in the ten-month period ending in October 2007 there have been 170 officers killed in the line of duty; this is compared to 145 for the entire year of 2006. This is the highest number of officers killed since 1978. Nationwide fatal shootings of officers is up 38% and officers involved in fatal vehicle crashes responding to calls are up 15%.

Some of the reasons for the increase is that gang members are heavily armed and out gun the officers. Another reason is repeat violent offenders. The system let's these violent criminals back out onto the streets and they have nothing to fear.

We are trained to shoot a person aiming or shooting at

us, period. In a fraction of a second our officers must make life and death decisions, we don't want our officer's to second- guess themselves. We want our officers to go home to their families after each tour.

Contract Negotiations

The discipline committee met with the city on 19 November 2007 and the City submitted their proposals to the Lodge. These proposals have been put on the website.

Behavioral Intervention System

This is a follow up from last month on the BIS program and a meeting with Interim Superintendent Dana Starks. The Lodge has been told that a meeting is forthcoming, when the meeting occurs the results will be made known to Lodge members. A grievance has been filed on the issue. My report last month should have stated that a list of 25 officers names are scheduled for release from BIS, these officers have served the time required by Administrative Special Order 05-02. Each officer will be released subject to the member's exempt commanding officer certifying that the member has substantially complied with the Individual Performance Plan (IPP), ASO 05-02, 5C, and the Superintendent's approval.

Sell or Carry Over

The end of the year is approaching fast and members will soon think about either selling or carrying over Personnel Days and Baby Furlough Days. The amount of time you have on the job determines how many Baby Furlough Days, (BFDs), you get. All officers receive four (4) Personal Days, (P-Days).

- 15 years or more receive 6 BFDs
- 10 but less then 15 receive 5 BFDs
- 5 but less then 10 receive 4 BFDs
- 1 but less then 5 receive 3 BFDs
- Probationary Police Officers receive 3 BFDs days the day they complete 12 months of probation.

Officers who have an anniversary date during the year, which entitles you to an additional BFD day, will receive the additional day on your anniversary date.

At the end of the year, you may sell back all of your BFDs or you may carry over up to 4 BFDs.

You may sell or carry over all P-days

Probationary Police Officers completing the 12th months of probation this month will receive 4 personal days. Rate of pay for sell back is computed as of April 1st the following year. Checks are also received on or around April 1st.

P-days or BFDs cannot be carried over for more then 1 year. For example, if you carried over 4 P-days or 4 BFDs from 2006 to 2007, you must use the carried over days by December 31, 2007 or you will lose them.

Chicago Police Memorial Foundation

The Foundation has expanded its levels of assistance to provide educational assistance for the children of CPD Officers who were killed or catastrophically injured in the line of duty. They are now offering tuition assistance for grammar and high school children of those killed in the line of duty. They are also offering tuition assistance for grammar, high school and college for children of Officers catastrophically injured in the line of duty, as well as educational assistance for Officers injured in the line of duty where the injury has impacted the Officer's ability to pay tuition. This is another step by the Foundation to ensure that the families of Officers killed and injured in the line of duty receive assistance as needed. The Lodge applauds the Foundation's persistence in recognizing and meeting its goal of assisting the Department's members and their families.

Financial Secretary's Report, By Tim Fallon

Duty Availability Grievance

On 11 July 2003, the Lodge filed a grievance on behalf of all probationary police officers who had completed the first twelve months of their probationary period. The issue was that these officers were entitled under Appendix P to a Duty Availability allowance of \$630.00 per quarter. On 10 July 2003, the Department issued the Duty Availability allowance checks to officers in the class in the amount of \$210.00 The Department arrived at this figure through pro-ration, from the time the officers completed their twelve months of probation until 10 July 2003.

The Department's initial position was that they had always pro-rated the Duty Availability allowance for probationary police officers. The Lodge requested documentation from the Department of this alleged past practice. At first the Department supported their position with documents showing that since 10 July 2003 all recruits had their Duty Availability allowance pro-rated. We again requested evidence that the practice of pro-rating Duty Availability for probationary police officers occurred prior to 10 July 2003. The Department then produced payroll documentation for probationary police officers prior to 10 Jul 03. After examining all of the Department's evidence it became clear that the practice of prorating probationary police officer's Duty Availability allowance began on 10 July 2003, not as the Department originally claimed. We also learned that there were some probationary police officers that had received their full Duty Availability allowance, and some officers within the same recruit class received different pro-rations on their Duty Availability allowances.

The Department then

changed their theory as to why they could pro-rate a probationary police officer's Duty Availability allowance. Department asserted that due to an arbitration award from Arbitrator Steven Briggs they were allowed to pro-rate Duty Availability allowance. arbitration involved a Lieutenant that was suspended for 30 days, and had his Duty Availability allowance pro-rated from \$555.00 to \$185.00. The Lieutenant filed a grievance and it proceeded to arbitration. In the arbitration the Department put forth the position that at all times since their initial implementation in 1990, the eligibility criteria have required that officers be in "pay status for at least 50% of the month. Those not meeting that threshold have been docked one-third (representing one month) of the allowance for that quarter. And there are many means by which they can remain in pay status while not being physically present on the job (furlough, benefit days, I.O.D., medical roll, military leave, etc.). The Department also testified that there are only three ways officers can become ineligible for the full Duty Availability allowance: (1) employment severance, (2) unpaid leave of absence, and (3) disciplinary suspension. And even in the latter two categories, the duration of the absence must be for more that 50% of the month. Arbitrator Briggs found the Department's argument compelling and denied the grievance.

While Arbitrator Briggs upheld the Department's position in the Lieutenant's grievance, there is nothing in the Department position that applies to the grievance filed by the Lodge. Probationary police officers do not fit into any of the three categories cited by the Department (and upheld by Arbitrator Briggs), where an officer becomes ineligible for a full Duty Availability allowance. Moreover probationary police officers who have not completed twelve months of their probationary period are routinely used for field duty to supplement non-probationary officers at festivals, parades, and special events.

The settlement of this grievance means that the Department now has to pay roughly 2,000 officers hired since July 2003, approximately \$400.00. Which means the Department owes approximately \$800,000.00 to the 2,000 officers. The bigger picture is that in the last six years since we have taken office, the Lodge has returned to the membership from the Department approximately \$3,000,000.00 through contract enforcement, the grievance procedure, arbitration decisions, and police board hearings.

Fitness For... "Our Finest"

Protect Your Back, Watch Your Backs

"Ouch! ... my lower back is killing me!" Sound familiar? The pain, tingling, or numbness down the leg(s) and "buttocks". It can be very painful to get out of your patrol car, bed, walking, and running. This certainly can affect your job performance, attitude and stress level. Just sitting for a long period of time, can be quite uncomfortable!

Nearly 50 million people visit the doctor each year for Lower Back Pain, which causes absenteeism at work, and drives up our medical bills and health premiums. Most lower-back pain is due to the lower vertebrae's, (L4, L5, S1) located by your back belt area, becoming inflamed and dehydrated. Your Sciatic Nerve attaches there, travels down thru your "buttocks" and down the back of your leg down to your foot area. The sciatic nerve is pinched or affected, thus sending pain across your belt and seat areas, like an electric current, and often travels down your leg. You should always seek the advice from a qualified physician (Orthopedic, for example) if you are experiencing pain for an extended period of time.

The leading causes for most, lower back pain are: (if not from an injury)

Weak Abdominal Muscles, Weak Lower Back Muscles Tight Hamstrings (most folks don't know this) Too much fat/weight in the stomach area

The solution: Exercising,

Stretching, and Realistic Eating (portion control). I will also be devoting future articles, in detail, to each of these areas. Some tips and suggestions for now:

Abdominal Exercises – Just 5 - 7 minutes / day, performing Stomach Crunches (sit-ups). Hold your stomach crunches for 3 seconds, don't go fast, and only come up half way off the floor – head looking at the ceiling, not your knees. Stronger stomach muscles take the pressure off the lower back, and aid when lifting and getting-up. Yes, sit-ups will strengthen your stomach but do very little for reducing the fat in the stomach area. That only comes with proper eating, weight training and cardio workouts. When you are at a stop light – simply tighten your stomach for 5 to 7 seconds, then release and breath. repeat a number of times.

Another exercise - try sitting with arms crossed, then stand and sit back down, making a stomach muscle and do this for a minute or so (up & down) slowly, at home or at work.

<u>Tight Hamstrings</u> - Stretch those hamstrings, on-the-job and at home. All stretches have to be held for 30 seconds!, not 10 seconds, like most folks think. The looser your hamstrings are (back of your thighs) the less pressure/stress on your lower back. It works!

Reduce The Stomach Fat-

This will also take lots of pressure off your back. This is accomplished by: Healthy Eating (portion control), Light weight lifting (building muscle burns fat) and Cardio exercises (walking briskly, running, biking and more). You can almost eat whatever you want, but just eat less, split the meal with your partner.

Spending just 10 to 20 minutes every other day with some of these exercises, will bring results and pain relief in just a short time.
