In the 11th hour of the Legislative Session in Springfield there was a flurry of activity. Some of it, as it played out, was not good for us but some of it went our way. As I reported in the June Newsletter, the language of our Pension Portability Bill was added as an amendment to SB2520. At the time the language was added on May 28th, SB2520 had already passed out of the Senate and was on 3rd reading in the House. This bill was then apparently identified as one which had a great probability of moving and passing prior to the legislature recessing for the summer. Another amendment was added later that day and a third was added

the following day. Our amendment passed out of two committees and was back before the House on the 30th as the other two amendments were sent to the Rules Committee. To everyone's surprise, a fourth amendment was added the morning of the last day of session which (as it played out) caused the entire bill to be delayed. It was eventually called up for a vote at 2200 hours that night and passed by a vote of 65 to 47. which was predominantly along party lines which happens often this late in the session. As it was a Senate Bill that was amended in the House, it now needed to go back to the Senate for a concurrence vote. Unfortunately, the Senate had recessed hours earlier. What does this mean now? It means that it cannot be sent to the Governor until the Senate votes on it but now it will need a 3/5th majority vote when they reconvene either later in the summer or in the Fall Veto Session. is a prime example of why men should never have to witness how sausage is made or legislation is, or is not, passed in Springfield. We remain optimistic that the Senate will vote favorably whenever they come back in.

Another issue that became extremely heated at the end of session was the attempt to not re-appoint Sal Diaz to the State of Illinois Prisoner Review Board. These appointments are made by the Governor with the approval of the Senate. Although Mr. Diaz's voting record can be classified as liberal, he has been a proponent of (all with just cause) denying parole for those who have been convicted of killing Police Officers.

There is a movement now that has had a measure of success to remove those members of the Board who are reluctant to vote for parole for those sentenced to "indeterminate" sentences. This type of sentence had been handed down to those who committed heinous crimes when there was no death penalty in the State of Illinois. Sentences of 100-300 years for example were given in cases when the Judge couldn't give the death penalty but wanted to ensure that the convict never walked free again.

Today those sentences are being considered for parole and are too frequently being voted in favor of. Most of those individuals convicted of killing Police Officers in that era, and there are a lot of them, have indeterminate sentences. The Prisoner Review Board is supposed to be made up of individuals from across the state who have experience in numerous related fields. Two years ago there were a total of three former members of Law Enforcement on the Board, today Mr. Diaz is the last and this attempt to purge him from the Board is a slap at our profession. There are few tasks that we have that are more important to our survivors than ensuring those convicted of killing Law Enforcement Officers serve their sentence, whatever it may be.

National News

In Washington the Social Security Fairness Act now has 75% of the House as cosponsors. Accordingly, National President Chuck Canterbury has called upon the Chairman of the Social Security Committee to call it out for a vote. There is still not enough support to pass it in the Senate at this time but a very strong House action could compel the Senate to act. Now that the Collective Bargaining Bill has passed out of the House and is gaining support in the Senate there is a full assault going on by the International Association of Chiefs of Police and the National Sheriffs Association against the passage of this legislation. It's a power thing. It appears that those in management, no matter how they proclaim to support organized labor for all of its benefits, now are taking actions to stop its enactment. These politicians and political appointees would rather keep the playing field tilted in their favor instead of leveling it for the benefit of our profession.

City Council

The Council last month voted to open up the process of Gun Registration for all residents who at some time allowed their registration to lapse for whatever reason. This is a stark difference to what was proposed by Alderman Mell due to his failure to re-register his firearms. There will be a time period opening up in the near future in which anyone who had previously registered a firearm in the City and failed to keep up with the annual ritual, including our retired members who have to re-register annually, will be allowed to do so to comply with the ordinance. When the opportunity opens up, the City will announce it and we will ensure that it is posted here in the Newsletter and on our web site.

IL State Lodge

The Illinois FOP State Conference is being held in Springfield on July 18th and 19th. Several important issues will be addressed but the one that may impact our membership the most is a potential dues increase. There has been an increase proposed and, if it passes, will become effective for 2009, which is the same time that the National increase takes effect. The underlying intent of the increase is that the State Lodge will get out of the solicitation business as we did here in Lodge 7 in 2003. The message that we received was that our members didn't want to be bothered and they were willing to pay their own way. That message will be the same when we vote on that amendment this month. We will address the full impact of both increases next month.

Firearms Safety Days

The Lodge hosted its annual Firearms Safety Days at the Hall on 10 & 11 June 2008. The event was a huge success with 566 of our members attending having their duty related weapons inspected and, in some cases, minor repairs conducted on sight at no charge. The line of police officers waiting to have their weapons inspected never ended from the time we opened the doors at the Hall until we finished the last handgun on both days at approximately 1830 hrs. The Representatives from all of the approved Firearms Manufacturers worked tirelessly both days, many without leaving their station for lunch. The lines were so long we stopped accepting one particular brand of weapon just after 1400 hrs with over fifty weapons waiting to be inspected. Our hope is to increase the Firearm Safety Days next year.

Parole Hearing For A Cop Killer—Carrasquillo

The Lodge was notified that a hearing before the Illinois Prisoner Review Board would be held to hear evidence for release of a convicted cop killer Ronnie 'Mad Dog' Carrasquillo, the murderer of Chicago Police Officer Terrance Loftus. On 10 October 1976, Officer Loftus was on his way home when he observed a youth being beaten in the street by a group of gang members. Instead of driving by and calling

the police from a safe distance away, Officer Loftus chose to do his duty and Serve and Protect this person from gang violence. He stopped his auto, announced his Office and immediately went to this person's aid, stopping these thugs from harming him further. A gang party was being held across the street and those attending the party immediately went outside to see who was interfering with gang business.

A passing squadrol observed the disturbance, recognized PO Loftus and immediately called for additional units to assist with breaking up the disturbance. Ronnie Carrasquillo was also at the party, armed with a handgun, and observed the police activity. Carrasquillo asked another gang member for a more powerful and accurate handgun. He took the more powerful gun, steadied himself against a parked auto and took careful aim into the street where Officer Loftus and the other uniformed police officers and citizens were standing.

Ronnie 'Mad Dog' Carrasquillo was warned by fellow gang members not to shoot; that these were police officers in the street: but he did not take their advice and fired his handgun four times. Officer Loftus was struck in the face by one of the bullets, fell onto the street and was taken to a hospital where he died of his wounds on 12 October 1976. Carrasquillo fled the scene and went into hiding, bragging to his fellow gang members that he had killed a 'pig'. An intensive search was held and Carrasquillo was arrested a few days later.

Carrasquillo was charged, tried and convicted of the murder of PO Terrance Loftus, Star #5701. He was sentenced by Judge Frank Wilson on 17 January 1978 to serve 200-600 years in the Illinois Department of Corrections. At that time there was no Death Penalty nor a Sentence of Life Without Parole and this indeterminate sentencing now transposed Carrasquillo into inmate#C801186 or what is also known as a 'C Inmate'.

Over thirty years has passed since that horrible night when Mad Dog Carrasquillo murdered Officer Loftus as he performed his duty Serving and Protecting the Citizens of Chicago. Carrasquillo, until this day, has never accepted responsibility for his actions or shown any remorse. Now, a group of influential supporters say that Carrasquillo is reformed, that he has changed, is a model prisoner, and deserves a second chance, and they are proposing that Carrasquillo be released early for his crimes. Officer Terrance Loftus was never shown any mercy, or given a second chance, when this coward deliberately fired a handgun into a crowded street.

A hearing before the Illinois Prisoner Review Board was held at 26^{th} & California on 18 June 08. Present at the

hearing were five friends and former co-workers of Officer Loftus, representatives of the Department, a retired Superintendent, the President of the FOP, the President and member of the Gold Star Families and myself. We each made statements to the hearing Officer along with presenting contradictory evidence as to why this murderer should not be released. We presented to the Hearing Officer copies of petitions with the signatures of 5.003 Citizens of the State of Illinois who demand that the Illinois Prisoner Review Board deny Parole for convicted murderer Ronnie Mad Dog Carrasquillo now and in the future.

The next hearing in this matter will be at Lawrence Correctional Facility on 8 July 08 and then the Embank Hearing on 31 July 08 in Springfield where the entire Illinois Prisoner Review Board will vote either to deny parole or release this murderer. We, as a Lodge, will continue to monitor with our watchful eye the actions of the Illinois Prisoner Review Board and particularly the cases of C inmates. Our wish is that the Illinois Prisoner Review Board will review this case and inmate Ronnie Carrasquillo will serve the remainder of his term in prison, as his lawful sentence was imposed.

Why Would Anyone Want To Be An FTO?, By Rich Aguilar

I have been a Field Training Officer for twenty-one of my twenty-six years on the job and this is probably the question I have been asked more than any other question throughout my police career. The reasons for the question are numerous; you don't have a regular partner, you never have the opportunity to bid to another district, you are limited to what districts you can bid to, there is the danger of working with an unknown and unproven quantity, the Department has made numerous promises over the years that they have

failed to live up to, and the list goes on.

Recently, four Field Training Officers were involuntarily transferred from their districts of assignment in the 014th District. The problem? The Department stated that there was an over-abundance of FTOs in 014 and an over-abundance of Probationary Police Officers elsewhere. The solution? Move the FTOs instead of moving the PPOs. This is the reward that these officers get for going the extra mile to do a job that few officers want to do. Apparently, the Department forgot one of the things

that they constantly stress to PPOs in the Academy. Know your location at all times. How does an FTO monitor and train a PPO when he, himself, may not know the layout and problems of a district that he has never worked in?

I have had the opportunity to speak with our new Superintendent on two separate occasions regarding the FTO program. Training is high on his agenda. He is concerned about the current status of the FTO program realizing that there is a need for improvement. His Chief of Staff, Michael G. Masters, and Deputy Superintendent, Peter Brust also expressed their concerns about the program and stated that they would work with FOP to improve the program.

I am asking that all current FTOs and any officers contemplating becoming an FTO contact me with suggestions to improve the program. Please be specific. Address a specific problem, as you see it, and formulate a solution for that problem. Tired of Being Tired?...Let's Fix That!

Research shows that millions of Americans <u>daily</u> complain of being tired. Many figure it's because they are too busy . "*I just have too much on my plate*". Sound familiar? Suppose I told you that the main reasons for feeling tired may be due to: 1) Coping with Stress & Energizing the Spirit 2) Getting the Quality Sleep Needed 3) Exercising & Healthy Eating Habits. Since, I have devoted previous months' columns to # 3, lets' focus on #1 & #2.

1) <u>Energize/Boost Your Sprit</u> - Mental strain will take a toll on you. Stress, worry, and anger, are all challenging emotions to deal with. But, if you take the proper action, your brain & body will rebound and you'll feel energized quickly!

Try these **4** tips:

 Splashing cold water on your face or dunking your head in a sink of cool water will take that edge off immediately.
Express your feelings & don't hold onto those bottled up fears & anxiety. Talk about them, write them down. 3) Turn on some favorite music. 4) Take deep breaths and exhale! When under mental stress, you may have a tendency to either hold your breath or take short, shallow breaths, which can make you dizzy, and sap you of your energy because you are reducing oxygen flow to the brain. Instead, take slow, deep (belly) breaths. To remember this, post tranquil photos (your kids, pets, vacation spots) in your patrol car, office, and lockers.

2) <u>Get Proper Sleep</u> – This can be especially challenging for those working 3rd& 1st watche. Research shows that more than 25% of Americans don't get the quality or quantity of

sleep needed. Without those 7 - 8 hours of sleep, your energy and productivity decreases, illnesses and anxiety may increase, and eventually you can "burn-out", which can be detrimental for Police Officers.

Try these 7 tips: 1) Exercising 4 to 5 times per week, will definitely help. 2) Reduce Caffeine consumption – drink caffeine-free diet sodas. Your coffee should sometimes be caffeine-free, or 50/50, & do not consume caffeine within 6-8 hours of going to bed (regardless of what watch you are on). 3) Don't eat a full meal within 4 hours of bedtime because your digestive system can keep you up. 4) Have dark shades in your room, to keep out the light. For the brain to signal "sleep time", it needs the dark. 5) If you enjoy falling asleep to the TV, set the timer so it goes off; say 30 minutes after you want to fall asleep. Also, try watching funny or old movies, they are more relaxing and make you smile/laugh more. 6) Lower your thermostat & open those windows for fresh, cooler air, so you are comfortable with a blanket. 7) Avoid the alcohol for 3 - 4 hours before bedtime!! You may think that a glass or two of wine or beer helps you fall to sleep, when in fact, it's a proven fact that alcohol interfers with the body's natural 24 hour biorhythms, which causes your blood pressure to rise and your heart rate to race, which causes restless sleep. Good luck, and see you next month!

**** TIP OF THE MONTH****

15 Minute Rule – If you cannot fall asleep, get out of bed, do something like walk, read, pet your dog/cat or sit on the couch and just "veg out". Do not get on the computer. Then once you feel sleepy, go back to bed.

Pension News, By Steve Robbins, Pension Trustee

In last month's FOP Newsletter I briefly described the historical origins of our Pension and how it eventually evolved to the current formula of 2.5% for each completed year to a max of 75%. With a few exceptions, an average of your last 48 months of pay will usually decide the amount of your monthly annuity upon retirement. There are a few other notable events that occurred during the last several decades that continue to have an effect on our Pensions today. Most noteworthy is the Constitutional guarantee provided by Article 13 of the Illinois Constitution passed into law in the 1970s, clearly stating that public pensions can never be diminished or reduced.

Another event would be the landmark Supreme Court decision of 1998, People-Robert Sklodowsky vs. The State of IL. This suit sought to compel the State to appropriate funds necessary to meet statutory funding levels contained in the Pension Code. The Illinois Supreme Court held that the Pension Protection Clause of the Illinois Constitution did not create a contractual basis for pension participants to expect a particular level of funding, but only a CONTRACTUAL right that they would receive the money due them at the time of their retirement.

In other words, we don't have a legal right to force the City to improve upon our current 51% funding ratio, however the Court re-affirms our right to receive our promised pension benefits.

NOTICE OF CLASS ACTION AGAINST THE CITY OF CHICAGO

In 1998 a class action lawsuit was filed against the City by several Chicago Police Officers who missed time from work due to injuries caused by third-party tortfeasors. Judgment has now been entered against the City. The lawsuit alleged that the City sought reimbursement for wages that it paid to these officers while they were injured and away from work by wrongfully asserting wage liens. These liens were asserted against and collected from the settlement or verdict proceeds that the officers obtained from the tortfeasors responsible for their injuries. The City denies it violated any law in seeking reimbursement.

If you are a current, former or retired Chicago Police Officer who, between 1996 and 2002, lost time from work due to an injury and as a result of your injury received funds from a third-party tortfeasors, and you have reasonable proof that a portion of those funds were paid back to the City for wage expenses, you will be entitled to settlement benefits. (If you were in the rank of Sergeant or Lieutenant at the time of your injury or if your wage lien was previously adjudicated by a court, you are not entitled to settlement benefits.)

Many of you will be receiving by mail a "Class Action Notice" from the Circuit Court of Cook County. The Notice describes the class action lawsuit and the steps you must take by July 1, 2008 to secure your rights thereunder.
