President's Report, By Mark Donahue

Negotiations

The Lodge and the City have given joint presentations each Wednesday evening these past weeks on the subject of the newly negotiated Retiree Health Care Benefits for those police officers who retiree from age 55 to 60. These presentations have included representatives from the Lodge, the City, Benefits Management, the Pension Fund, Deferred Comp, Social Security and the Financial Planning Center of the Patrolmen's Credit Union. If there were any questions that needed to be answered, these representatives did a great job at doing so. As the entire agreement has been posted on our website for six weeks now, it is hard to believe that any members, except for those who may have been out of town on furlough, are not aware of this enhanced benefit and have not come forward with their questions. It is our understanding that the Supervisor's representatives have negotiated a version of this benefit for their members and their members attended the presentations as well to get informed.

As was reported in the August Newsletter, the agreement requires a minimum number of individuals to apply for retirement during a set time frame for the next three years. For this first round of applications that number is 160. The Department has established the process by which to apply on the CLEAR system and the deadline for the first round is October 1st for those who are at least 55 and wishing to retire between November 1st 2009 and March 31st 2010. The system is also accepting applications now for those who wish to retire in the second cycle from April 1st 2010 thru December 31st 2010 with an application deadline of January 1st 2010. This retirement enhancement benefit was negotiated for at the direction of the membership who wanted the Lodge to assist in alleviating the costs of retiree health care. Conservatively, this benefit could be worth as much as \$100,000.00 over the course of time until the retiree becomes Medicare eligible. Although the Lodge surrendered nothing in exchange for this benefit other than allowing the City to save revenue at a time when they need it most, it is now up to the membership to take advantage of this negotiated benefit.

By the time you receive this Newsletter, we expect to have decided upon an Arbitrator for the upcoming process. We continue to meet with the City, most recently on August 26th, in an attempt to reduce the number of issues which will have to be addressed in the arbitration process. We have had a measure of success in doing this and will attempt to continue this in the future.

The Lodge continues to attend the meetings of the Labor Management Cooperative Council, or LMCC, to keep current on the progress of this initiative to reduce the costs of providing healthcare for all City employees. The progress here has been limited and the Lodge has continued to discuss our proposals concerning healthcare with the City and has not yet agreed to become part of the LMCC as the City has proposed.

National FOP Conference

The National Conference was held August 17-20th in Long Beach CA. The Lodge sent 52 Delegates made up of Board Members and Unit Reps as is directed in the Constitution and Bylaws. The business of the Conference included addressing issues of importance to members of Law Enforcement across the country. There were Constitution and By-law proposals that were voted on as well as the election process for the two contested offices of 1st Vice President and Secretary. The entire Executive Board was returned to their positions except that we now have a new Chairman of the Trustees. Our State Trustee, Robert Nowaczyk from FOP Troopers Lodge 41 was seated for his eighth consecutive term. Trustee Nowaczyk is also expected to be retained as the Chairman of the National Easter Seals Committee. Your National Board has made tremendous progress in all areas of representing law enforcement and deserves to be re-

Fiduciary Responsibility At The Pension **Board**

The Lodge has had a Pension Committee in place for seven years now. The Pension Committee goes to every

pension board meeting and monitors what goes on. The Board's attorney David Kugler reviews each disability case and then makes recommendations to the trustees. The trustees have the option of reading the entire file, which many times can be hundreds of pages, or reading Kugler's abbreviated notes. My opinion is that some of the Board members only read Kugler's notes rather than the entire file. By not reading the entire files, some trustees make bad decisions on whether an officer will receive disability benefits and at what level those benefits are given.

I believe that our Police Pension Fund is the most reversed Board in Illinois. Since I have been serving at FOP, our win rate on court appeals of Pension Board decisions is near 50%. It should not be close to that high if the Board were doing its job and making correct decisions.

Believe it or not, attorney Kugler does not receive a salary from the Pension Board. He is paid by the hour. What does this mean? Well, in 2008 the Board spent more than \$240,000.00 on legal services, up about 12% from the 215,000.00 it spent in 2007. We can only assume that this money was paid to Mr. Kugler, the Board's lawyer. The Lodge believes that it is a mistake for the Board

to pay an attorney an hourly rate, particularly when it amounts to nearly a quartermillion dollars a year for a part time job. The Board could hire a very good lawyer as a full time employee for that kind of money. The way it is now, the more appeals that are taken from bad Pension Board decisions, the more money Dave Kugler makes. Bad decisions actually benefit the Board's lawyer. If the Board did the right thing a little more often, it could save a lot of time and money.

The Lodge doesn't want anyone to get a disability benefit that doesn't deserve it and we also don't want our officers' that were disabled doing their job having to jump through hoops to get it!

Payflex Flexible Spending Account Ouestions and Answers

What is the Flexible Spending Account (FSA)?

The FSA account helps you save money on your out-of-pocket health care expenses. By using this accommodating plan you pay certain expenses with pretax dollars from your FSA account. Here are some common expenses that you can use your FSA account to pay for: health care deductibles, co-payments, other expenses not covered by your health care plan and amounts over the maximum amount of what is a reasonable and customary limit your plan pays for. Furthermore, you can also use your FSA accounts for over the counter medicine, dental procedures braces/dentures, smoking programs, corrective eye surgery, weight loss programs, acupuncture, female contraceptives/condoms, oxygen equipment, cosmetic surgery caused from an illness or accident, ect. A complete list

of covered expenses can be found online at www.cityofchicago.org/benefits. How much money can I put into my Flexible Spending Account?

Here is a break down of how the FSA account works. You choose the amount you want to have deducted per pay period from an annual minimum of \$120.00 to a maximum of \$5,000 annually and all the money is protected by taxes.

Does the Fraternal Order of Police Lodge #7 recommend it's members to enroll into this program?

Yes, the Lodge would like to see all members enroll into the FSA account program because it is a great program with a pre-tax savings that all members would benefit from. Furthermore, let me give you a couple of examples on how great this plan is.

Example: Assume 25% tax rate and \$1,000 in medical expenses not covered by your health care plan. Officers without the tax benefit FSA account need to earn \$1250 to pay for medical expenses of \$1,000. Officers that are enrolled in the FSA account get the benefit of using \$1, 000 without tax to pay for medical expenses.

Example: Let's say that you have a child that needs braces and the amount of the braces is going to be \$1200. You have \$50.00 deducted from your account every pay period for a total of \$100.00 a month going into your FSA account. The FSA account begins in January and ends in December and you just found out in March that your son/ daughter needs braces and they cost \$1200. Well you realize that you only

have about \$300.00 in your FSA account. Your FSA account will loan you the additional \$700.00 that you need to get your child's braces done.

Can I get reimbursed if I don't use my entire deposit amount?

Keep in mind that the money you have in your FSA account is a "use it or lose it" type of plan. All claims must be incurred by December 31st of the calendar

vear, however you do have until March 31 of the following year to submit any claims.

When can I enroll into the Flexible Spending Account?

For anyone that would like to enroll into the FSA account the only time you can enroll into this plan is during the open enrollment period.

When can I make changes to my Flexible

Spending Account?

For anyone that would like to increase/ decrease the amounts that they currently have going into their FSA accounts they can also make those changes during open enrollment. Furthermore, anyone that is currently enrolled into the FSA account and would like to opt out of this plan the only time for you to opt out is also during open enrollment.

Fall Uniform Resale

The Fraternal Order of Police Semi-Annual Uniform Resale will be held at the FOP Hall on Wednesday 21 October 09 from 1300 hrs until 1800 hrs. Officers take advantage of this event

if you are looking to purchase an additional uniform item or to sell those uniforms that are no longer worn. Officers wishing to sell their uniforms items need found guilty in a court of law and senonly to come into the Hall and set up on one of the tables which the Lodge provides before the start of the resale. Officers who wish to donate their uniforms for the Lodge to sell need only drop these uniforms off to the Lodge Office up to the day of the sale.

Parole Hearing for Cop Killers

The Lodge was notified in Mid Au-Chicago gust that the Illinois Prisoner Review Board will hold hearings in the fall of 2009 at 26th & California to consider early release for the convicted murderers of PO Herman Stallworth, Star #10965, 003rd District, EOW 24 May 1967, PO Kenneth Kaner, Star #2662, 007th District, EOW 19 June 1970 and PO Terrance Loftus, Star #5701, 014th District, EOW 10 October 1976.

These convicted cop killers were all tenced according to the law at that time. These murderers were all sentenced under a system which has come to be known as the C Inmate system because there was no death penalty or life without parole as we know it today.

The Lodge upon learning of these

hearings immediately circulated to every Unit/District City Wide each of the individual Petitions to deny parole for these convicted cop killers along with a fact sheet. Please sign each of these Petitions when you see them in at the Desk and return them to the Lodge.

We will present the signed petitions to the Illinois Prisoner Review Board at these hearing along with voicing our opposition to any possibility of parole for these convicted murderers who have not completed their lawful sentence. Lodge will continue to monitor these cases and watch over the actions of the Illinois Prisoner Review Board to ensure that no cop killer is released before completing their sentence.

Aldermanic Clout

Alderman Anthony Beale of the 9th Ward is being investigated by the Feds over his daughter's admission to Whitney Young High School. On 25 Aug 09 the Al-

derman appeared on WTTW Chicago Tonight show along with a student who was denied admission to Walter Payton College Prep, a community activist and a Chicago Tribune reporter. The straight A student's only flaw was that she was absent for a few days because she had the flu and that was enough to deny her admission to Walter Payton College Prep.

Alderman Beale's daughter attended Providence St. Mel's school and she never applied to attend Whitney Young High School. The Alderman explained that the problem was because St. Mel's never told the students or the parents the criteria for admission to Whitney Young High School and by the time he made inquiries the application deadline had expired. Alderman Beale stated that he called Principal Joyce Kenner and told her that his daughter was an outstanding student and a very good athlete and he wanted her to attend Whitney Young High School. Alderman Beale got his wish and his daughter was admitted to Whitney Young on the 5% rule.

Later in the interview Alderman Beale related that he has made numerous phone calls on behalf of 9th Ward constituents requesting that their children be admitted to public college prep High Schools. He makes it sound like; don't put me in a bad light because my daughter was admitted...I tried to do the same for other

The problem with this is simple. The 9th Ward boundaries are roughly 99th Street to 138th Street, the Bishop Ford expressway on the east to Union on the west. I can't help but wonder if there is just one other student inside those boundaries who Beale called and got an

Needless to say the reporter and community activist as well as the student think this system of clout calls for High School admission is wrong vet the Alderman doesn't see the problem.

This is the same Alderman who is one of the biggest spenders of the Aldermanic Discretionary fund that doles out 3.7 million to the Alderman to spend. With all of the talk of how bleak the City finances are, Paul Volpe is trying to squeeze every nickel he can out of labor but doesn't see the opportunity to save 3.7 million dollars by eliminating the Discretionary fund?

a reporter around the 9th Ward in his brand new SUV purchased with the City money. The reporter questioned the Alderman on the wisdom of purchasing a SUV with the price of gas and Beale dismissed the concerns explaining how he must drive in snow covered alleys in the winter to inspect garbage pick-ups. This is just symptomatic of what is

staff are on the airwaves everyday reciting how revenues are shrinking because of the economy and telling the media how dire the financial situation is for the City. It just doesn't play anymore. We are without a contract for twenty seven months and going to arbitration. have to sit back and watch the politicians use clout to get their children into college prep highs school while we pay seven, eight and nine thousand dollars a year to send our children to private high schools because we don't have the clout call. We can't pick up the phone and call Joyce Kenner at Whitney Young high school This is the same Alderman who drove and get our children admitted with the 5% clause.

> The one bright spot in this tragedy is that Alderman Beale will be able to drive his daughter to Whitney Young College Prep in a SUV that we paid for while using our gas.

> The Mayor will defend Beale and his chest that they are just acting as parent would. The problem is that we as parents can't act like Alderman; we just don't have the clout. The Feds have served subpoenas and are currently investigating this case. Let's hope they bring it to a successful conclusion.

Unpaid Furlough Days

City workers are being forced to take unpaid furlough days to help the Mayor. Someone needs to look at how much money is being saved with the left hand only to be spent with the right hand. Lawyers for the Corporation Counsel's Office are required to take seventeen unpaid furlough days as a result of the budget crunch. On its face, this appears to save the taxpayers money. However, the truth is that the furloughs actually increase spending. The City has hired private law firms to do the work that was being done by the now furloughed corporation counsels. These lawyers bill at a rate far higher than that of the corporation counsels salaries who were furloughed. What a con job!

Jody Weis' Letter to Judge Holderman

I know that while lawsuits are frivolous each lawsuit is different and each lawsuit presents different risks for those being sued. I think the smartest thing to do is let each officer consult with the Corporation Counsel and let them make an informed decision as to whether or not the case should go to trial. Only the officer and his family can decide if the officer wants his day in court to clear his name and that decision can not and should not be made by anyone else. Only the officer being sued and his attorney can know the risks of being assessed with punitive damages.

I think it is clear from three recent lawsuits that have gone to trial and resulted in five officers being hit with punitive damages ranging from \$33,000 to \$66,000, each the risk is real.

While this information may sound redundant, it might help you, the member, in acquiring a bid position that seldom opens.

A member of my flock called and asked, "My heart is heavy and I'm hurting and feeling depressed due to many of life's challenges, emotionally and financially. What can I do to lift my spirits?" The to himself. question reminded me of the following story....The Hospital Window

Two men, both seriously ill, occupied the same hospital room. One man was allowed to sit up in his bed for an hour each afternoon to help drain the fluid from his lungs. His bed was next to the room's only window. The other man had to spend all his time flat on his back. The day. men talked for hours on end. They spoke of their wives and families, their homes, their jobs, their involvement in the military service and where they had been on vacation. Every afternoon, when the man in the bed by the widow could sit up, he would pass the time by describing to his roommate all the things he could see outside the window. The man in the other bed began to live for those one-hour periods where his world would be broadened and enlivened by all the activity and color alone. of the world outside.

Young lovers walked arm in arm amidst flowers of every color of the rainbow. Grand old trees graced the landscape, and a fine view of the city skyline could be seen in the distance. As the

man by the window described all this in nurse responded that the man was blind exquisite detail, the man on the other side of the room would close his eyes and imagine the picturesque scene and smile

One warm afternoon the man by the window described a parade passing by. Although the other man couldn't hear the band – he could see it in his mind's eve as the gentleman by the window portraved it with descriptive words. Independent Auditors Report For Chicago, FOP Lodge #7

Fraternal Order of Police, Chicago Lodge No. 7—Legal Defense Fund Financial Statements Years Ended December 31, 2008 & 2007

We have audited the financial statements of FRATERNAL ORDER OF POLICE, CHICAGO LODGE NO. 7– LEGAL DE-FENSE FUND for the years ended December 31, 2008 and 2007, and have issued this report. These financial statements are the responsibility of the Organization's management. Our responsibility is to express an opinion on these financial statements based on our audits.

We conducted our audits in accordance with auditing standards generally accepted in the United States. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation. We believe that our audits provide a reasonable basis for our opinion.

> There was no way that I was going to vears old, and tell him that nothing could be done. I made several attempts to contact the Director of Human Resources, Tracey Ladner, to solve Tim's problem. Director Ladner never returned any of my calls. The next step was to appeal

Administrative Services. Theodore O'Keefe. A letter was sent to Deputy Superintendent O'Keefe, in March 2009, explaining the problem. I offered to personally pick up the star, send it via FedEx at my expense, and supply the Department with a signed and dated receipt.

The response denying my offer was received in August 2009, some five months later, not from Deputy Superintendent O'Keefe, not from Director Ladner, but from a sergeant in Human Resources who the issue was apparently dumped on. The response and the way it was handled was not a surprise at all. You see, Director Ladner and Deputy Superintendent O'Keefe are both civilians. Neither of these individuals ever took a step in Tim Mosher's, or any other police officer's, shoes. Apparently they just can't relate to the fact that all Tim wants is a star that he earned and is probably meaningless to anyone else or maybe they simply just don't care. Hopefully, someone will step up to the plate and do the right thing while Tim Mosher is still with us.

The idea is that this procedure should monitor which firms are selected to present in front of pension funds. Other changes in the law seek to minimize the potential for trustees' conflicts of interest. This is a watered-down and toothless piece of legislation which may in fact wind-up helping those very insiders it was designed to police.

The term "Ethics Reform Bill" sounds paper. Unfortunately, too many politicians got their hands on this bill and the result is that this "Ethics" bill offers little in the way of reform and has quietly turned into a minority set-aside bill. As part of this legislation, our pension fund now mandated to include a "quantifiable and obtainable goal" for minority owned and women owned businesses. This means a percentage of our money must be invested with an "Emerging Manager" - not the best performer or most prudent investment, but a group as defined by the Illinois state legislature. Initially the House of Representatives wanted to mandate a goal of 12% minority managers. The Senate removed the 12% number. Now "we" must obtain

ally to the Committee on Pension and Investments.

How is this legislation protecting us? There is absolutely no mention in this "ethics reform bill" of the funding status problems that our pension funds have incurred. Yet they are quick to issue mandates as to how our money is to be invested. Our fiduciary obligation to select the best and brightest money manager should trump any Legislative decree compelling us to invest a certain way.

Obama Detail

Members who work the Presidential Protection Overtime Initiative should be aware of notification changes that have been made. Per the release of AMFN Message No. 092970 on

21 JUL 09, it is now the officers responsibility to check the I-Clear systems to confirm both assignments and cancellations. Officers who report for duty if they have not been scheduled to work or have a day cancelled will not be paid. If you are RDO or on Furlo, it is your Watch Commander's responsibility to notify you of any cancellations or changes of your assignments. Be aware of this change in particular when the President is scheduled to be in Chicago and cancels or changes his plans.

National Conference

The Fifty-Ninth (59th) Biennial Conference of the Grand Lodge, Fraternal Order of Police was held in Long Beach, CA, during the week of 16 AUG. During

this conference, I attended Seminars pertaining to the Fair Labor Standards Act and Robert's Rules of Order. Michael Coviello of the National FOP Labor Services was the lead instructor for FLSA seminar. I felt this topic was important because of the recent Heitmann Case. The Robert's Rules of Order was very informative in that it analyzed parliamentary procedure. This is the set of rules for conduct at meetings. These procedures are important because it allows everyone to be heard and make decisions without confusion. As in past conferences, a common topic discussed by National Board members and other Lodges was the involvement of the members. It is important to get involved with the FOP. in your unit or district, call the FOP and request a representative to speak at roll calls.

When parking at Headquarters. IPRA, the Credit Union or the Lodge, make every attempt to park legally. Apparently the Department of Revenue has targeted these areas. In fact, one officer related that he parked on 35th Street where there are signs posted indicating, "For Police Business Only." The officer was mandated to be at HQ and still received a ticket. I personally observed an individual from the Department of Revenue issue citations to several vehicles near the credit union. Apparently discretion is not taught to meter maids. If you feel a citation was issued improperly or in error, exercise your right to contest the alleged violation.
