## President's Report, By Mark Donahue

#### Pensions

Official Publication of Chicago Lodge No. 7

Although many aldermanic positions are set for run-off elections in the near future, the position of Mayor is not one of them. On February 22<sup>nd</sup> Rahm Emanuel was elected as Mayor of the City of Chicago. The fact that a generation of Chicagoans have known no other mayor than the one who currently fills that seat, this campaign, as well as the decades that have passed since we have had a new Mayor, have caused many to wonder what will happen now. A concern for us and one that took center stage during the election is what position the new city administration will take on our pensions.

The Illinois General Assembly took bold steps last year to address the unfunded pension problems that effect every fund in the State. After forcing a new plan on every other fund in the State except Article 3, 4, 5, and 6 which represent Downstate Police and Fire and Chicago Police and Fire, the Unions representing the participants in these four funds were able to "negotiate" a new plan. That new plan was encompassed in SB3538 and impacted the benefits of future hires that would participate in these funds. The major change, and probably the most important change for the Chicago Police and Fire funds in their history, is that the bill changes the way in which the City of Chicago will now contribute to the funds. The "Actuarial Required Contribution" (ARC) replaces the "Multiple" system. The most important component contained therein is that the City now has the obligation to ensure the necessary contributions into the fund where under the "Multiple" system, we were informed they felt they had no obligation to ensure the viability of the funds. And the guarantee that the City does so now is that if they don't, funds will be swept from any state grants and placed into the funds. Downstate Police and Fire funds have had the ARC for years but until now, they haven't had this built-in enforcement mechanism to ensure the local municipalities properly fund them. To address the current underfunding of the City's pension funds, the question is, does the passage of SB3538 go far enough in assisting the City to reasonably meet their obligations?

Another question that needs to be decided prior to being able to competently negotiate further changes with the City to ensure the solvency of the City and the Funds, is what is their position relative to the constitutional guarantee that denies diminishing the benefits of current participants (both active and retired CPD members)? Our position is and will remain that SB3538 addresses the only diminishments that can be made regarding benefits in that only the benefits of "future hires" can be diminished. Our decision to negotiate to that effect was based on that belief. The positions of the business groups and some legislative members ( that yet to be earned benefits of current employees can be changed), stands in stark contradiction of the constitutional guarantee. **Please note that "no one" has ever recommended that the benefits of those who are already receiving a pension can be diminished.** If there are to be successful negotiations with the City in addressing the solvency issues, it must be from the position of our belief that current employee benefits cannot be diminished.

It is the intent of this Union to address the issues of fairness that we have identified such as a widows COLA as well as the COLA for those retirees who turn 55, in conjunction with addressing the City's concerns for a trailer bill to SB3538 which can drastically curtail the immediate liability of taxpayers (and we too are taxpayers). Nobody wants the City or State to go belly up. We will work toward ensuring this does not happen. I stated a number of months ago that the resolve for the funding problems that the City identified lies in a trailer bill to lessen the percentage level standard for the fund to as well as lengthening the time in which to do it. That would be something like the now required 30 years to get to 90% funded becoming 50 years to get to 80% funded. Initial reports show that this change in legislation would take the

liability for the taxpayers from 550 million down to 330 million. An amount that even by conservative estimates could be financed by a Chicago-based casino. If there is more that needs to be done, the negotiating table is where it needs to happen. There, everything is open.

As far as being able to act, both of the leading Mayoral candidates stated that this problem could be worked out and it It's all or nothing at all. With this in appears that the Mayor-Elect has recently taken a position that could be more conducive to that happening than before. As we anxiously await the opportunity to do so, we will keep working the issue here and in Springfield and want to assure our members that the problems can be worked out. It will require a lot of work, but it can get done.

#### **Attacks on Unions**

Wisconsin, Indiana, Ohio, Michigan and Minnesota are all, or soon to be, battlegrounds for those who see organized labor as the cause for all that is wrong with our economy. It's funny in a way, but it took all of about 18 months for the "Wall Street Dragoons" to turn the pointed finger of blame from themselves to Unions and Public Sector employees but this time they scoff at bailouts. It's equally unfortunate that money talks. But it couldn't have this kind of influence in turning the blame had it not been for the likes of some political groups that will

assist them in bringing down organized labor with the hope that it will enhance their political position in this country. I believe that those who are seeing this move for what it is realize that, say for instance those who identify with those who call themselves Tea Partiers, come with an agenda. And it is an agenda with which there is no room for compromise. mind, for years I have heard it said that we as Policemen are Republicans with Democratic needs. Conservative in thinking but a little liberal in recognition of the resources we need to do our jobs and provide for our families. This at times can become problematic and a good example of this happens when endorsements for political candidates are being considered. For so many of our members who, when polled, felt the endorsement for our recent Governor's race should go to the Republican candidate. Even though we knew his position on pensions, in that he felt all new employees, and possibly current ones should be placed in a 401K type plan and get the State out from under that liability. His position on labor was not in our favor as well and in consideration of what is happening "up north", is there anyone who feels that our last Governor's race was a arrive at the solutions. loss for our interests? Big business and never survive and personal agendas need the far right have seriously diminished to be left at the door.

collective bargaining in the private sector for a whole generation of workers. It's not hard to see why they now want to go after Public Sector Labor, because there is a cost, one that they are not willing to allow to impact their bottom line. As I said last month, it's time for all union members to rally around their union. Your union will fight your fight here in the City, in Springfield and in Washington. We are only as successful as you allow us to be. But think about, or talk to those of us that were here before the union contract in 1981. We are much better off now than then and so is the City and the Department. The Unions establish a level playing field for all so that none of us, neither employees nor management are harmed by those whose personal agendas don't include anyone/anything but themselves.

So let's not be fooled by the agendas at work in the mentioned states and to an extent right here in Illinois. The success of the employers, whether they be municipalities or private industry, is dependent on the employees and vice versa. Commitments are made from both sides and both sides need to honor those commitments and when difficulties arise, both sides need to come together and Dictatorships

#### **FOP Elections**

By the time this newsletter reaches your home, the results from the FOP Election will be in. Like every FOP election there is a lot of misinformation

that is passed out and said at roll calls. Sometimes this is done intentionally and other times this is done because of a lack of knowledge. It would be nice if our members running for elected offices would stick to the facts and tell the members what they plan to do to make things better for FOP Members. Many are able to do this, but there are always some that feel they have to make things personal. It shouldn't be personal. We have the largest FOP Lodge in the Nation. We should be proud of the benefits that our elected officials have obtained for us over the last 30 years.

The next time that you are at the Lodge offices, when you get off the elevator, take a look in the glass case to your left. In there, you will find all the old contract books dating back to our first collective bargaining agreement. Our first contract was only 40 pages. Our current contract has over 142 pages to it. These are not benefits that the City just decided to give to us. These are benefits that were fought for by your elected officials.

Members need to get their information from their Union. not from the Internet. If members come to a Union meeting, they will be informed. If you are receiving your Union information solely from the Internet, you will probably be misinformed. If you are a member that sits in roll call and "MF's" the Union about something he/she read on the Internet, then shame on you if you didn't pick up the phone or come to a Union meeting and find out the facts. We are the police and we are smart enough to learn the facts before we take a position on something. What I am asking every member to do is to stop bad mouthing the Union and your fellow officers. Nobody is in bed with City Hall. Whoever takes charge of our Union needs the backing of the membership. Not just the membership that voted for them, but all the membership. Politi-

cians are challenging our collective bargaining rights and attempting to diminish our pensions. These are big fights ahead and we must be united. We are only as strong as our membership allows us to be.

#### House Bill 1198- Trustees Positions on Our Pension Board

For years now, Sgt. Mike Lazzaro has been an elected Trustee on our Pension Board. Lazzaro tells anyone that will listen that we need to be more like the Firefighters Pension Fund, often praising the way that the fund conducts business. However, one thing Mike Lazzaro does NOT like is the way that firefighters elect their Pension Board Trustees - more "at large" elected spots. Sgt Lazzaro is dead set against making any changes in the way that our Pension Board Trustees are elected. He does not want to run in an "at large" election. But the Lodge doesn't believe that the current makeup of the Pension Board is fair to our members.

To address the disproportionate representation, the Lodge submitted Legislation in Springfield to remove the limitations on the rank of policemen who may serve as the Pension Board Trustees. The reason is simple. There are eight Trustees on the Pension Board. Four are appointed by the Mayor and four are elected. One is elected by FOP members. One is elected only by the Sergeants, one is elected by Lieutenants and above, and one is elected by the retirees. Seeing that approximately 90% of the Fund's participants are members below the rank of sergeant, we feel strongly that this overwhelming majority is not adequately represented on the Board. We have watched over the years how our money is invested by our elected Trustees and have been disappointed with many of their choices.

We are not asking that anyone be removed from the Board. That is a choice that is made at election time. We are not trying to take away supervisors' representation on the Board. Local 2 has supervisors on their Board that are elected at large. Sgt. Lazzaro also has been heard complaining that FOP Board Members are attempting to control and manipulate the Pension Fund and that these actions have been detrimental to the Fund. He doesn't state who these FOP Board Members are. If this is true, shouldn't he tell us who these Board Members are? Sgt. Lazzaro is clearly worried about being re-elected to the Pension Board. If he was doing his job right and fighting for us at the Board and watching how our money is spent, Lazzaro would have nothing to worry about. The Lodge will notify its members when HB 1198 is up for a vote so that you may call your representatives and let them know how you feel about this needed legislation.

Mayor Emanuel And **His View On Our** Pensions

Rahm Emanuel was interviewed by the F.O.P. Political Action Committee and he talked extensively about City

pensions. Emanuel believes that we have earned 2.5% towards our pension for every year we worked, but believes that he can change the percentage earned going forward, forcing us to work longer for a lesser benefit. Emanuel does not have the authority to make that change because our pensions are protected by Article XIII of the State Constitution, which guarantees that our pensions cannot be diminished or impaired. Emanuel also said that any City Worker who is retired has earned their retirement benefit and he believes that their earned benefit **cannot** be changed.

With that being said, can Emanuel try to change our pension benefit for active employees? He could try but we, along with the other 42 unions, would be in Court to stop any change that is brought This very issue was argued forward. three different times before the State of Illinois Appellate Court and all three times the case was thrown out because it was ruled unconstitutional. The only time a change can happen in our pension is at the State Constitutional Convention, which can't happen for another eighteen years. That can only happen after a referendum is voted for requesting a Constitutional Convention be held. #### The Fight for Collective Bargaining and Pensions

What do Rahm Emanuel. New Jersev Governor Christie and Wisconsin Governor Walker all have in common? They have all made the same statement; "public sector employees have been made promises concerning pensions from politicians who had no intention of keeping these promises."

Three different people from three different parts of the Country and all are making the same quote. Make no mistake, there is a concerted effort nationwide to attack public sector employees and their pension plans across the nation. Wisconsin Governor Walker is on a mission to destroy the public sector unions as evidenced by Legislation designed to end Collective Bargaining. The unions sat down at the table and offered a proposal wherein they would accept paying more Tribune and his analysis is that Emanuel Collective Bargaining. Another compro-

unions paying more for benefits and would remove Collective Bargaining for just two years. Walker has rejected both proposals, insisting unions give up their Collective Bargaining rights. The old saying rings true, you give them your hand and they cut off your arm.

People have already forgotten that Legislation ending Mandatory Collective Bargaining for public sector employees in Indiana. The politicians in the state of Ohio are talking about passing Legislation as early as next week eliminating the arbitration process for public sector employees. Under their scenario you would bargain until an agreement is reached or when you reach impasse you just receive the cost of living percentage for the year. Public Sector Labor contracts would be negotiated every year.

In Illinois, public sector employees are not faced with losing Collective Bargaining and there is no Legislative agenda to eliminate Collective Bargaining. Representatives in the Senate and House are still trying to grapple with the State pension issue and the House is exploring the possibilities of change to current employees while the Senate has said that any such change would be unconstitutional.

It is going to be a bumpy ride for a while but rest assured this is a fight we and all City Unions are ready to fight.

#### **Firearm Safety**

The Lodge recently learned of a potentially dangerous weapon malfunction that can occur daily without the Officer being aware of

the problem. When the magazine on a semi automatic pistol is not seated and locked in place properly it will cause the weapon to malfunction. If the weapon is fired while the magazine is not seated it will only discharge once and will not cycle a second round into the chamber, rendering the weapon useless. In the event that your weapon does not fire a second round, tap, rack and assess the

situation. Maneuvering this procedure should make your duty weapon operational.

This dangerous malfunction does not occur due to mechanical failure but can happen as easily as a jacket bumping against the magazine release or after District weekly weapons inspection not properly seating the magazine. A procedure which is recommended is the occasional tugging the base plate of the magazine to ensure that it is seated properly in the weapon ensuring it is operable. A daily examination of your duty weapon prior to starting your tour of duty along with proper maintenance will also ensure

that your duty weapon is operational and in the event of life threatening situations ensure that you will be protected.

The Lodge, in an effort to assist our membership, will host the Firearms Safety Days on 25 & 26 May 2011 at the Hall from 0900 until 1700 hrs. Attending this year's event will be the Representatives of the approved Firearm Manufacturers who will conduct onsite inspections of our member duty related weapons at no cost. Officers take advantage of this free worthwhile program which the Lodge has arranged for your benefit.

### How Am I Responsible For This? A lot of non-Police Officers

read our newsletter. This article is directed at them since the Chicago media outlets usually refuse to pub-

lish our side of the story. For all of the Police out there; I am sure that my story is not any different than yours. It could apply to any one of us.

Let me start by stating, I am a Police Officer. I am also a taxpayer. Police Officers have become the scapegoat for all of the ills of both State and City government budgets. We are somehow responsible for bankrupting the coffers of both with all of the benefits that we are perceived to have hoodwinked them out of.

Let's get the facts straight. I, like all other Police Officers, had a choice. I could have continued working in private industry or gone into public service. Had I made the choice to stay in private industry I would have had the opportunity to make considerably more money during my working career. I would have been able to relocate outside of the City of Chicago and lived where I chose to live. I would have had the opportunity to send my three children to public school at no additional costs to me other than my local taxes. I would have been off on evenings, weekends, and holidays, meaning I could have spent every Christmas with my family, attended every birthday party, wedding, etc. I would not have been subject to the rules of my job twenty-four hours a day. I would not have broken any bones doing my job. I would not have been threatened with bodily harm.

I chose to go into public service. I am not complaining about the choice that I made. I made a conscious choice to forego all that I have mentioned thus far, but that decision was made based on promises that were made to me when I started my career as a Police Officer.

I was promised free healthcare for me and my family both while I was working and when I retired. The City of Chicago reneged on that deal less than a quarter of the way into my career. I was promised a fair pension in exchange for the sacrifices that I would have to make. Now, suddenly the public is up in arms about the "generous" pension that some believe is "free money" for those in public service jobs. I am more than aware of the economic times that we are facing and understand that to someone who cannot find any or adequate work that my pension might seem extravagant. I have family members who are in the same position. What the public doesn't seem to be aware of is the fact that I have contributed nine percent of every paycheck that I have earned since I took this job and paid property taxes while I have lived in the City to help fund my pension.

I guess my question is quite simply this, why wasn't this an issue during my first twenty-five years of service? Our Pension Board and our Mayor were presented with a yearly actuarial report that advised them of the contributions that were needed to maintain the Pension Fund. Neither the Pension Board Trustees nor the Mayor took the steps that were necessary to properly fund the City pensions throughout the years. If they had, this would not be an issue today.

There are currently sixty-five money managers allegedly working for the Pension Fund. I say allegedly because some of these money managers consistently lose money yet they continue to stay on and collect fees for their services. Why isn't there some incentive-based program put into place by the Pension Fund Trustees if these managers want to continue to be paid for their services?

Fortunately someone had the foresight to have our Pension Fund protected by the Illinois State Constitution. Fortunately the FOP and IAFF had the foresight to assure legislation was passed that ensures the funding of our Pension Fund for the future.

There is more than enough blame to go around as to why the Pension Funds are currently a problem. Just don't blame me. I have fulfilled my end of the bargain. The City now needs to do the same.

Time certain allows Lodge members to step up to the microphone and address members from the Board of Directors with questions they may have. FOP thanks all its members who took the time to complete a ballot and mail it back in a timely fashion, also to all members who voted in the mayor's race. Exercising your right to vote is a privilege which carries weight for the Lodge for many reasons.

#### **Ambulance Service**

Last month I wrote about ambulance service which spoke about coverage for active officers (sworn members only). Retired police officers are also covered under a Fire Department General Order 93-005 which states, "Retired fire and police personnel will be given the same consideration as an active member". Exception: Immediate family of retired fire and police personnel is defined as a member's spouse only.

#### **Daylight Savings Time**

Mark your calendars to set clocks ahead one hour on March 13, 2011. Day-

light Savings Time is the practice of temporarily advancing clocks during the summertime so that afternoons have more daylight and mornings have less. Typically clocks are adjusted forward one hour near the start of spring and are adjusted backward in autumn, Nov 6. Members who forget will be late for work, church or whatever you do if

#### Watch Bidding

Watch bidding may occur in districts and units starting on March 09, 2011. Section 31.5 (filling of vacancies) covers watch bidding. If and when the employer decides to fill a recognized watch vacancy by bid, such vacancy to be bid shall be posted on the seventh calendar day (Wednesday, March 09, 2011) of the third police periods and shall remain posted for seven (7) calendar days (Wednesday, March 16, 2011) from the day of posting. Members who are newly assigned to a unit may be placed on a watch at the employer's discretion until such time as the member accepts a management position or is able to bid on a vacancy. Members in the following categories may also bid; personnel concern, limited duty/convalescent duty, restricted duty or relived of police powers. The Department reserves the right to change a successful bidder's watch assignment for the duration of the time in which a member is included in one of the categories listed above. A steady watch vacancy occurs when a member performing the assignment is: permanently transferred, permanently reassigned, resigns, retires, dies or when the Department increases the number of members on a specific watch in any of the designated units as

identified in the existing bargaining agreements. A steady watch vacancy exists only if the Department announces the vacancy and elects to fill the steady watch vacancy. If the vacancy is a bid vacancy, then the vacancy will be filled by bid. If the vacancy was appointed (management) at the discretion of the Department, then the vacancy will be filled at the discretion of the Department. Only eligible bargaining unit members currently assigned to the unit where the vacancy exists may bid for the existing vacancy by submitting the Watch Selection Request Form. Department Special Order 02-16 may be reviewed for guidelines in submitting a Watch Selection Request Form.

## Everything Happens for a Reason

For the last two years of his life, Bruce Cummings lived at a Nursing Home in Uptown. Bruce had no family or friends

who stopped in for the occasional visit. Even though there were other people living in the nursing home, Bruce was alone. On October  $7^{\text{th}}$ , 2010, that's how Bruce died at Weiss Hospital, alone.

The 23<sup>rd</sup> District conducted the death investigation. Upon notification to Area 3, The Sgt. taking the call heard the name Bruce Cummings and thought it may be a retired copper. The Sgt's instincts were correct. Operations Command confirmed Bruce had retired from the Chicago Police Department in 1999. After his death, no relatives came forward to arrange for his funeral services. As a result, Bruce became a Public Administrator's Storage Case, which meant that Bruce Cummings would be buried in Potter's Field in an unmarked grave. However, Bruce's Police Family wouldn't let that happen.

Through the tireless work of the Personnel in the 23<sup>rd</sup> District, Father Tom Nangle and the Chicago Police Memorial Foundation, Bruce was given a funeral and proper burial at Abraham Lincoln Cemetery. Bruce had served honorably in the United States Marine Corps.

The question now remains, how many more of our brothers, active or retired, are alone? The answer is unknown, but hopefully there is a solution. On February 4<sup>th</sup>, 2011, the Destitute Police Officer Sub-Committee met for the first time. The committee consists of Chair Jim Molloy, Father Tom Nangle, Capt. Tom Lemmer of 23, Toby Kucharski, Cook County Public Administrator's Office, Detective Dave Spelich. Retired Officer Bob Graeber, Phil Haskett of Peer Support, John Gordon from the Chicago Police Memorial Foundation, Ken Hauser of the PABF and yours truly. The purpose of this committee is to ensure that none of our brothers and sisters are left alone, without a family to help them. For those that do pass away with no family to step forward, it is our job to give the officer a funeral and proper burial. It is the least we can

do considering the sacrifices made by our officers on a daily basis.

We want to let officers who are living under these circumstances know that they are not alone. If you know of an active or retired officer who is alone in a nursing home, hospital or managed care facility, please inform the committee. Information received in regard to these cases will enable volunteers to take the first step in providing help.

#### **No Kidding!**

For quite some time now, there has been much discussion regarding police shootings; in particular, when the shooting officer should give a statement. It has been the position of the Lodge that an officer should be allowed to give a statement at least 72 hours after the incident. After all, the Department views an officer involved shooting as such a traumatic incident that the officer is given three days off. The Independent Review Authority disagrees. IPRA's position is that it is important that an officer give a statement as soon after the shooting as possible so that the integrity and perception of the investigation is not affected. Never mind the fact that the officer hasn't slept, in some cases, for over 24 hours.

In the February edition of American Police Beat, IPRA's position regarding the timeliness of the statement is challenged. In a study done by Dr. Bill Lewinski of the Force Science Institute, there was a strong correlation between how much rest a person had and their memory. The study revealed that those individuals who were well rested gave more accurate and detailed descriptions of a particular incident opposed to those Deceased Brothers & Sisters

who were not. In research done by the American Journal of Forensics Psychology, it was concluded that the deprivation of sleep may cause the brain to cause false memories. In the article, Officer Involved Shootings researcher Dr. David Klinger maintains that just under 50% of officers involved in shootings have difficulty sleeping during the first 24 hours after the incident. For some officers, sleep issues continue for at least one week after the shooting.

That being said, what is the hurry for statements? IPRA has six months to complete an investigation. If more time is needed, a request to the City Council is made for an extension on the time limit to complete the investigation. The Lodge is currently awaiting an arbitrator's decision regarding this issue and the time frame in which an officer will give a statement for a shooting. Hopefully the Arbitrator reads American Police Beat.

## **Proposed Amendment to Constitution Article 5, Section 1**

In August 2011, at the National Fraternal Order of Police Biennial Conference in Salt Lake City, Utah, Illinois will have a candidate running for the office of President of the National Fraternal Order of Police. Current State Lodge President Ted Street has announced his candidacy with the backing of the Illinois FOP Board of Directors. Lodge 7 has, at their December 7, 2010 Board of Directors meeting, committed their support to President Street's campaign. The importance of this commitment by both Ted Street and this Board is one which rises to a level which has significant importance to the Lodge and we feel compelled to propose an amendment to our Constitution under Article 5, Section 1. The amended portion of the existing Section is emboldened.

#### Article V Representatives

Section 1

A Lodge Representative for each District, Area, or other Police Unit shall be elected by the members of the Unit he/she represents and he/she be a member of the Unit he/she represents. Said elections are to be held within 90 days, following the election of Lodge Officers. The elected Unit Representatives of the Lodge may, by virtue of their office, be delegates to the State and National Conferences. If an elected Unit Representative is unable to attend either a National or a State Conference, he/she may recommend a Watch Representative to attend in his/her absence. Such recommendation shall require the approval of the Lodge Board of Directors.

The Board of Directors finds that this properly proposed Amendment is recommended for passage by a vote of the Membership at the General Monthly Meeting on March 15, 2011.

## Where Did The Time Go? By Bill Nolan

In thinking about an article for this newsletter, and for all practical purposes probably my last article, my first thought is, where did the time go? Going back to January of 1963, when the Fraternal Order of Police was formed in Chicago, all of the Officers of the FOP at that time had only one thing in mind, and that was to help all Chicago Police Officers in their daily work environment.

Maybe it was just a coincidence that most of the early Officers all worked out of the old Area 4, Maxwell Street station, which included Homicide, Task Force and Traffic Units, but that is where the leadership of the FOP was born. On a personal note. I will always be grateful to these early leaders who started me on the road to FOP leadership including Dineen, Higgins, Learas, Skelly, Belmonte, Lis and many, many more on the State and National levels.

After serving as a Unit Representative from Area 4 Homicide/Sex Unit, I ran for office in the FOP Lodge 7 for the first time as Sgt. at Arms and was re-elected twice. During the third term, we were close to getting the Collective Bargaining Bill passed for Police Officers and Detectives only. On one of the saddest, but proudest Board meetings we attended, all of the elected Officers of the Board who held higher ranks in the CPD, without exception, stood up and resigned so the Lodge could move forward in the world of collective bargaining.

When this Lodge was first formed we had a Captain, a couple of Lieutenants and several Sergeants who served on the Board of Directors. Their heart was with the FOP and our mission, but the Labor laws had to be followed at that time, so in a spirit of Fraternalism these early leaders, because they were fortunate enough to have been promoted in their career, had to leave the job of getting the first ever contract for Chicago Police Officers. Due to these events, I was appointed to fill out the last two years as Treasurer. I was then re-elected three more times as Lodge Treasurer until the opportunity was there to run for Lodge President. I was proud to be elected and re-elected twice as the President of the largest FOP Lodge in the having to take a life in the course of duty, Country. pioneers in the area of watching out for all Police Officers and their successes and dedication will always be remembered.

As the Lodge membership grew it was obvious that we could not continue holding monthly meetings with alternate north and south side locations. His ideas and dedication are evident throughout the Hall.

Some of our other earlier achievements, since winning the right for Collective Bargaining was payroll dues deduction, hiring full time attorneys, establishing the Legal Defense Fund and one that only effects a few, the By-Law change that limits the term of the President to three terms only. I for one believe, and I think the current President agrees, that three terms is enough.

It is a tough schedule that keeps going 📺 24/7 and after awhile it can take its toll. But it has also been one of the most rewarding challenges because if, during my terms, I have saved at least one Police Officer from losing his or her job, or to help them through the traumatic events of

satisfied. For the last nine years I have served as the Immediate Past President and I hope that I was able to convey some advice or help along the way.

While this concludes thirty-six years of serving as an Officer on the Chicago FOP Board of Directors I have also been fortunate to have been elected as your FOP National Treasurer for eight years and serve on the National Board along with Past National President John Dineen. The President of Lodge 7 is a full time, hard working job servicing over 17,000 members. When John Dineen was elected President of Lodge 7, he stepped down after one term as our National President. When I was elected President of Lodge 7, I stepped down as our National Treasurer after four terms; in other words you cannot serve two masters and Lodge 7 deserves the full commitment of their President.
