55 Premium-Free Health Insurance The Lodge has received many calls regarding the premium-free health insurance when retiring at age 55. There are many

officers that believe that this benefit will not be there after 30 June 2012. That is not correct. That date will mark the end of the current contract. Everything in the contract continues until there is a successor agreement (example - you still get your same vacation days until the contract is settled or we receive an arbitrator's decision). This benefit is spelled out in our contract in a Memorandum of Understanding on pages 120-123 of the Collective Bargaining Agreement. Any member taking advantage of the premium-free insurance must notify the department before October 1 of the year prior to when they plan to retire and the date that they plan on retiring. This benefit was negotiated by the FOP and was not given to us by an arbitrator. Both the Lodge and the City benefit from this agreement as it truly is a win-win for both sides.

Medical Section Complaints

The Lodge has received numerous complaints regarding nurses and the doctor at the Medical Services Section (MSS). If an officer has an issue with a nurse at the MSS that needs to be addressed, the officer should ask for a These complaints can sergeant. sometimes be addressed with the sergeant and at other times may be addressed through the complaint register process. You as the individual officer can decide what route that you want to take. The doctor at the MSS is another story. There isn't a day that goes by that I don't get a complaint about the MSS Doctor. Some of these complaints are justified and others are not. It seems that the doctor is getting her marching orders from the Director of Human Resources. If you have a complaint regarding the MSS Doctor you can either attempt to invoke the CR process or contact the Department of Financial and Professional Regulation,

Choosing A Doctor When Injured On Duty

Per Section 18.8 of the Collective Bargaining Agreement, the Lodge and the City have agreed upon procedures that must be followed by the Medical Services Section (MSS) when an officer reports an injury on duty or a recurrence of an injury on duty. These procedures are set forth in Appendix N of the agreement, on page 78. Appendix N dictates what the MSS can and cannot do when you are injured on duty. Officers also have the right to select a physician from the Workman's Choice List, not have a doctor chosen for him/her. This is in our CBA on page 116. Any questions, please contact the Lodge.

Questions You Have About Retirement, But Were Afraid To Ask One of the most important decisions a police

officer will make during their police career is when

he/she will retire from the Chicago Police Department. Many police officers will often talk about retirement, discussing their future hopes and plans to enjoy those golden years in leisure, and how to plan financially for this transition. Many police officers attend the pre-retirement seminars and read as much literature that is available to make informative decisions. There are many police officers who make the choice to retire not knowing what to expect or not having made a plan for the future. I have recently received a number of telephone calls from police officers who are planning on retiring in the near future. Many likely have questions and are confused about the procedures regarding applying for retirement. There were a variety of questions asked with inquiries of different facts regarding retirement. I did some research and learned that there is no written outline of the procedures providing police officers with some type of guide. I will try to answer some of the most commonly asked questions.

There are different variables regarding retirement depending on the age of the applicant and his/her time in service.

- The minimum age for retirement is 50 with 20 years of service.
- Officers reach their maximum benefit for service at 29 years and a day.
- Officers who retire before the age of 55 must pay for their health care, per the Korshak Agreement.
- Officers must retire by age 63 regardless of time in service.

There are two separate retirement benefits which the Lodge obtained for our members outlined in the Contract. 1) Officers who retire on or after the age of 55 and before the age of 60 shall receive premium free health care provided they follow the guidelines set forth in the Contract. Officers must file before 1 October the preceding year (online) informing the Department of their intention to

retire along with the effective date. Effective 1 October 2010, and every year thereafter, officers need to file for retirement under this provision along with agreeing to certain terms and conditions for payment of final compensation. 2) Officers who retire after the age of 60 will receive premium free health care and need only apply and be approved with no terms or conditions.

Officers who make the decision to retire should pick a date that will work for their individual needs. I have been told that the best time to retire is on the 15th of the month but this is only a recommendation, not an exact science. Officers, when retiring, should make sure they do not have any bad time (suspension, leave of absence or unpaid time) to make up to avoid being short service time you thought you worked. The Department will not tell you if you retirement check.

Officers should also check with Internal Affairs to learn if they have any open or pending CR numbers. The Department will not issue you a retirement star or identification card if there is an open investigation. If this is the case you can not qualify for conceal and carry under HR 218.

ment must complete the application from a Department Computer completing a Clear Form which must be submitted to the Director of Human Resources for approval.

The approval process usually takes approximately 3 weeks and it is the Officers responsibility to make sure it is approved. Once the application is approved the Officer should contact the Pension Board notifying them of their intention of retiring and to learn the amount of their monthly payment.

The Officer must have an exit interview with their commander before their last day worked.

Officers should ensure that their current contact information along with the proper beneficiary is listed with the pension board, credit union, deferred compensation, and the FOP.

The big day that the Officer picked for are short, but only lower your monthly retirement will finally arrive. The Officer will turn in his Department issued equipment (helmt, batton, ...) and should receive a receipt. The Officer will be brought to Human Resources where he/ she will be issued their retirement identification card and star.

Submission of DNA Evidence by Police Officers

The submission of DNA Evidence (Buccal Swabbing) of Police Officers for duty related matters (weapons discharge incidents, aggravated battery of a police officer) has been the subject of some recent incidents. The subject is not governed by any General Order or Department Directive and there is nothing mentioned of the submission of DNA evidence under the current Collective Bargaining Agreement or the Police Officers Bill of Rights.

If you are involved in an incident where, during the course of the investigation it is determined that your DNA evidence will be needed for the case. The officers will be presented with a Consent to Collect Biological Samples form. The form reads that the person to submit to this procedure has a constitutional right to refuse consent without a judicial order being first obtained. The form advises the person that he will now give his consent for this procedure and the samples that are taken will be forwarded to the Illinois State Police Laboratories or other appropriate lab for further analysis. The form then states that this analysis can and will be used in criminal investigations and will be turned over to the States Attorney's office or other prosecutorial agencies. If the person is charged, the analysis may be used as evidence against the person.

The submission of DNA Evidence is strictly done with your approval and permission and is voluntary. If you agree with the terms as stated on the form you would sign and then comply with the Buccal Swab. The submitted DNA evidence would then go into the Codis System along with registered sex offenders, felons and recent parolees. Parole Hearing

On 28 July 2011, the En Banc Hearing took place before the Illinois Prisoner Review Board in Springfield for the convicted murderer of PO Edward Barron 14571, 004th District, EOW 28 September 1973. Along with 28 other Chicago Police Officers, I traveled in the predawn hours by bus (provided by the Chicago Police Memorial Foundation) to attend this hearing before the Parole Board. The Parole Board reviewed all of the presented evidence. Arguments were made by both those who favor release and those opposing parole. A motion was made and properly seconded to deny parole.

The Illinois Prisoner Review Board voted 7-2 to deny parole for this convicted murderer and gave the case a 1-year set.

I would like to personally thank each of the Officers along with the representative from the Chicago Police Memorial Foundation who made the long, early trip to Springfield to support the memory of PO Edward Barron.

No Second Guessing So far this year, July 26, 2011, there have been 41 officer involved shootings where the offender was struck by the police gunfire. During the same time

period there have been hundreds of attacks, batteries and assaults on the police where no one was struck by gunfire. This is a hot topic with many media outlets at the moment trying to figure out why police shootings are up from the last four years.

CeaseFire, which according to their website, is a "violence prevention program" focused on changing the behavior in a small number of "carefully selected members of the community". Also according to CeaseFire, they are dedicated to preventing gang on gang shootings. But where are they when it comes to preventing violence against police? A CeaseFire report states that 40% of their "selected members" are either on probation or are parolees. They do however claim considerable success in increasing seatbelt use and condom use among their clients.

Well, the director of CeaseFire, Tio Hardiman, gave a statement to the Chicago Sun-Times relating he has a belief that police have a "license to kill" mindset where police "are going to get the crime down no matter what it takes". Why does CeaseFire even rate comment relating to police involved shootings? They should stick to talking to parolees about condom use and seatbelt use. I agree with one part of what Hardiman states and that is: "no matter what it takes" ... no matter what it takes for our officers to go home at the end of their tours.

The director of IPRA, Ilana Rosenzweig, told the Chicago Sun-times that she does not know why police shootings are up for the year. Now that sounds logical but then she went on to say that it is possibly because of systemic causes involving training or police policy. I'm not sure where Rosenzweig was going with this or what exactly she means but I will interpret it as: "Training" - officers resort to

their training when faced with a die or Just in from being called out to two sepalive situation, and "Police Policy" which in some cases prevents officers from being the Police and allows offenders to become brazen from lack of being policed.

Two factors I see that pose no arguments are: no fear of the police, and a shortage of police officers. Attrition takes place thereby providing less and less officers to educate these "select members of the community". Just another reason we seek additional hiring of police officers. seek additional hiring of police officers. guess yourserves in a die of inte structure.
Over periods of time these members of the community may become more and more fearless, reckless and lawless, and the number of police involved shootings may continue to increase. The Vanishing Beat Cop

OK, you've got me. I stole, make that borrowed, the title of this article from an article by Ben Joravsky that appeared in the Chi-

cago Reader some time ago. Those of you who haven't read it should. It has some great content addressing the diminishing amount of Police Officers on the streets of the City of Chicago and the problems that Police Officers face as a result of this lack of manpower. The author even mentions a confrontation between some gangbangers who actually taunt the Police and the Police fail to respond allegedly due to a lack of backup because of the manpower shortage. The problem I have with the article is that it sounds as if the author and the Police Officers interviewed think that simply adding more Police Officers is the answer to solving all of the evils of the City.

I am certainly not going to take the position that less Police Officers is a good thing. We do need more Police Officers; many more. As a matter of fact, when I started my career there were more beats per district. Even the day watch beats were manned by two-man cars. There were three wagons per watch per district. We had a minimum of six two-man power cars (rapid response cars for some of you new guys). Can you imagine that? Today, there are many districts that have one-man cars as a mainstay even on midnights. Mr. Joravsky's numbers were correct. Manpower is down and something desperately needs to be done about it, but here is where I will take it a step further and state that the diminishing number of Officers isn't the only reason that the beat cop is vanishing.

This is the point where Police Officers can probably stop reading. This is also the point where the media, liberals, politicians, and those citizens who want to be protected need to start paying attention.

There was a time, if you will excuse the expression, that Police Officers went out, kicked ass and took names. Whoa! I am

sure the hairs on some of your necks are possession of a fully loaded pistol or that standing on end in reading that expression. No, I am not talking about POLICE BRUTALITY. I am talking about Police Officers responding the only way that the majority of the bad guys understood; the threat of or the actual use of force. Most of the bad guys even expected it.

Today, Officers are expected to use terms like "sir", "please", "thank-you", and other miscellaneous forms of courtesy. While these terms and courtesies may have their place in the normal world, they are at most times viewed by the bad guys as some kind of a weakness in an Officer. I don't think it's a coincidence that batteries committed against Police Officers have increased by three hundred percent over the past decade.

There was a time when the threat of an arrest meant something. A person caught doing the wrong thing lost his freedom. The only way out of jail was to post a cash bond or go before a judge. That process could take at least a day or two or maybe longer. Getting arrested was a deterrent.

Today, the bad guy gets an I-bond sometimes even before the Officer has completed all of his paperwork. Jail is now a place where you can cool off on a hot day or get warm on a cold one for maybe an hour or so, chat with your gangbanger homies, and, if you're lucky, maybe even get a sandwich.

The Legal Defense Fund is the funding source for members who are in need of, and entitled to, legal representation for a duty

related incident. There are instances in which it is not clear as to whether the officer's disciplinary/legal issues are duty related and warrant paid legal coverage. When such circumstances arise, members can appear before the Legal Defense Committee to explain why they believe they are entitled to coverage. The appearing member must demonstrate to the board that their situation is the direct result of their duties as a Chicago Police Officer. Members appearing before the Legal Defense Committee seeking paid legal representation are encouraged to provide committee members with records or documentation that might assist the board in making a decision. Members appearing before the board with supporting documentation stand a better chance of success at gaining approval from the Committee as opposed to those who arrive empty handed. Please provide supporting documentation with your request when possible.
