# President's Report, By Michael Shields



#### **Police Officer Clifton Lewis**

Regrettably, I must begin my article with news of a Fallen Officer. Police Officer Clifton Lewis was fatally shot in the line of duty on December 29, 2011, during a robbery. Officer Lewis joined the Chicago Police Department in April 2003, and his assignments included the 008th District, 011th District and 015th District. He was a dedicated law enforcement professional and demonstrated a commitment to serving and protecting the City of Chicago.

He was recognized with numerous awards including four Department Commendations, a Unit Meritorious Award, seventy Honorable Mentions, two Crime Reduction Awards and two Complimentary Letters.

Please keep Officer Lewis and his Family in your prayers at this difficult time.

#### MFF

The Department is establishing a new unit, the Mobile Field Force Team (MFF), which will be used for the G8 Summit in May, and in the future for other similar large-scale events. Per a memo from the Bureau of Patrol, "personnel selected to join the team will go through extensive training," and will be "required to purchase the necessary equipment." So, while the Department suggests that being selected for this "specialized team" is an honor for those with excellent records and performance ratings, they "reward" us by requiring that we purchase \$800 worth of our own uniforms.

More importantly, however, these units are not covered by the contract. Therefore, although this is not a full-time assignment, and officers remain in their current watch and day-off groups, when we join these non-bid units, we sign our contractual rights away. I'm urging all members of the FOP to protect the contract. Do not sign up for this. Do not let the Department "reward" you by taking your rights away.

Most importantly, I want our officers to remember how SOS, Mobile Strike Force and Targeted Response Units were "rewarded" for their great police work. These officers can now be seen working midnights in 005, 003 and 021-far away from their original units of assignment. We, as FOP members, have to take a stand against the Department exempts' continuous promises of "taking care of the workers." Take a stand against this. Force the department to do this entire initiative reverse seniority.

For those officers that do agree to this: You will agree to sign your contractual rights away. You will also be foolish enough to purchase your own supplemental uniform and equipmentno one should do this, regardless of what unit you are in. Unfortunately, somebody always does. Do not be that somebody.

#### **Media Coverage**

We have seen a new administration come into Chicago and dazzle the press with words such as "efficiency," "accountability," "eliminating duplicative functions," and other catchy phrases that they love to use throughout every single department in the City--not just the Police. Within our own department, the catch phrases include, "the backbone of the department is in the beat," "1,000 new officers on the street," "1,000 officers moved from their desk jobs," and other phrases that sound great, but we know do not represent the truth for our membership. Luckily, the media isn't buying it. It has been openly discussed in the press that Chi-

cago has a serious manpower issue. While the City may continue to push their propaganda that "less is more," the big picture is that the City of Chicago is balancing the City's budget at the expense of public safety. The FOP has consistently challenged the City on this serious issue and has defended our membership in every media outlet available to us.

#### **G8/NATO Summit Training**

As we all know, the G8 and NATO Summits will be held this upcoming May here in Chicago. Based on past protests at these events, which are often held in more quiet and remote locations than Chicago, we are told we should be prepared for potential civil unrest, property damage, and perhaps even terrorist attacks. **Limited Duty Update** Last month I wrote about the new order regarding limited duty changes. The Lodge has filed a Class Action Grievance regarding these changes which

were never agreed to. In this same grievance, the Department has also violated Section 18 of the collective bargaining agreement by changing the eligibility requirements. All officers now applying for limited duty must be able to effect an arrest of an active resister. Who will determine if an officer can effect the arrest? Once again not much thought was given to these changes before they were made. In meetings with the Commander of MLAS, he was asked how this was going to be determined. He was asked if he had contacted the Pension Board to see what position the Board was going to have with potentially hundreds of officers applying for disability. The Commander had no answers. The problem with this issue is that you have civilians running this Department that have no clue what it is like to be a police officer. Director Ladner is now giving officers letters to give to their doctor regarding what the essential functions of a police officer are. Now she has changed the new order from effecting the arrest of an active resister to

an officer must be able to punch, hit, kick, run, climb, squat in order to work limited duty. If an officer could do all of the above that would make them full duty. The department is attempting to eliminate limited duty assignments by changing the eligibility requirements. Any officer who is forced to go on the medical roll because they are refused a limited duty assignment should file a grievance at the Lodge.

#### Appendix N Violations

The Medical Section's Deputy Director (she's really a doctor; you're only a policeman) Arjmand has decided that officers can no longer have a selection of physicians from the Workmen's Choice List and that she will personally choose three physicians that she has handpicked that officers can choose from. Not only does this violate our contract, but it sounds like the same type of steering that was going on in the 90's that a supervisor was fired over. Why would the Department want another black eve? Why would the department want to limit who officers injured in the line of duty could be treated by. The only rational explanation is that our Deputy Director Arjmand wants to control the outcome by handpicking the physician. If any officer who 4. is injured on duty seeks treatment and

is not able to pick from the entire Workmen's Choice List, they should contact the Lodge to file a grievance.

#### **Tour of Duty Exchange**

Members who are denied time off could exchange a tour of duty with another member from their unit/watch. This is just a reminder of what an officer needs to do if he/she is going to request a tour of duty exchange.

When an officer requests the 1 use of compensatory time off at least seven (7) days prior to the requested date and is denied, the Department shall be required to notify the requesting officer of a denial no less than three (3) days before the requested date. If denied the slip should be given back to the officer.

2. The requesting officer will identify an eligible full duty officer (from his unit and watch), who 1) is not scheduled to work the date of the requested Tour of Duty Exchange and 2) is willing to work the date of the requested Tour of Duty Exchange.

The requesting officer will 3 agree to work a tour of duty on a specific date for the replacement officer within four weeks, before or after, the requested Tour of Duty Exchange date.

A minimum of twenty-four (24) (Continued on page 3)

hours before the exchange date, the requesting officer and the replacement officer will submit a report to the Watch Commander indicating they have agreed to the exchange of days. The Watch Commander must then approve the Tour of Duty Exchange or may grant the original request for elective time.

5. Requesting officers are limited to one (1) Tour of Duty Exchange per ment on the medical roll (non-IOD) will police period.

6. The replacement officer involved in a Tour of Duty Exchange will not be allowed to use elective time to satisfy his or her Tour of Duty Exchange obligation.

7. An officer that is unable to fulfill his Exchange obligation due to place-

be ineligible for participation in Tour of Duty exchange for 90 days.

#### **FOP Medallions/Active** Member Stickers Every year the Lodge mails

out thousands of active member and family window stickers to our current mem-

bership both active and retired. After the initial mailing the Lodge will then receive requests for additional active and family member stickers by our members. The Lodge attempts to honor those requests within reason, but accepting those additional active member window stickers creates some responsibility for our membership. The active member FOP window stickers should only be displayed on autos currently registered to that FOP member's household and not given to just anyone. The same rule applies to displaying a FOP medallion that should only be on an auto which is currently registered to an active or retired police officer who is a member of FOP. The displaying of those window decal stickers and medallions identifies the auto as belonging to an active or retired police officer. This is a safety issue because police officers who observe these autos on the street identify with them as belonging to a police officer but that is not always the case. The Lodge receives several calls monthly from officers in the field who find autos they have come in contact with that are displaying the medallions or stickers by persons who should not be in possession of these items. Anyone displaying FOP medallions or an active member sticker who is not authorized to do so can be arrested and charged under 720ILCS5/17-2 with impersonating a member of police fraternal or veteran's organization or represen-

tative of charitable organization use of the words Chicago Police etc. Officers when you sell or dispose of your auto please make sure that you remove the old medallion and stickers. The possession of these medallions or window stickers is a privilege allowed by your profession and not a right.

#### 2012 FOP Vest Safety Day

The Lodge will be hosting a Vest Safety Day at the Lodge on 16 February 2012 from 0800 until 1700 hrs. The Representatives of the various soft body armor companies will be at the Hall displaying the current models of their products. Officers, if you need to replace your old vest or just want to see the most current The Employee Assistance Program models, stop by the Hall. The soft body armor which we wear on a daily basis is one of the most crucial pieces of uniform equipment we put on when we hit the street that will protect us during a time of danger.

The following are some historical facts regarding the wearing of soft body armor by Chicago Police Officers:

The wearing of soft body armor was voluntary during the late 1970's and early 1980's and many Chicago Police Officers did not wear this equipment at this time.

The wearing of soft body armor became a reality for Chicago Police Officers in February 1982 when three Chicago Police Officers (James Doyle, William Fahey & Richard O'Brien) were killed in the line of duty within a five (5) day period. These senseless acts of violence enraged and motivated the then sitting mayor to begin a fund raising effort from the business and civic community along with private donors. The combined efforts resulted in raising enough funds for the purchase and distribution of soft body armor for all Chicago Police Officers.

This act of charity helped bring awareness to the members of the Chicago Police Department of the importance of wearing soft body armor. It would be many years later before the wearing of soft body armor was required for the members of the Department who worked the field to wear soft body armor.

#### The Endorsement Process

Gratitude goes to every member of the Lodge 7 Political Action Committee for the hours and days put

into to recent endorsement process for the upcoming March 20th Primary Election. Keeping in mind the existing attacks on collective bargaining, labor, and public employee pensions, PAC members were tasked with making decisions which ultimately affect the future and viability of this organization and the membership. Some of the candidates made these decisions very difficult, while others made it very easy.

Some of the decisions made by the fifteen member Political Action Committee and the full Board of Directors have been unpopular with a few of our members; like anything else, not everyone can be accommodated. But it's not about "me, me, me," it's more like "we, we, we." It's about this Fraternal Brotherhood and this organization. Lodge 7 has received a small number of responses that indicate there is a need for an explanation of the Lodge 7 endorsement process.

The Lodge receives requests for political endorsement for candidates seeking a variety of offices. During this past PAC process, and prior to January 9th, 2012, the Lodge received 109 requests for Judicial, Legislative, Clerk of the Court, Board of Review, Ward Committeeman and Water Reclamation offices. Judicial included the Illinois Supreme Court, Illinois Appellate court, Countywide, and Sub-circuit courts and Legislative included Illinois Senate and Illinois State Reps. No requests for Aldermanic races were received and no endorsements were made in the Ward Committeemen or Water Reclamation races.

Upon receiving these requests, the phone calls, emails and correspondence flowed in from active members, retired members, widowers, police associations, elected officials, unions, organizations, etc. all providing some level of input. Most were detailed and informative and were taken into consideration. Sorry, but solely based on being the police, or, "Being a good guy/gal", or, "FOP better endorse him/her!" is just not enough for a recommendation for endorsement.

When making recommendations for endorsement, the Political Action Committee follows the FOP policy and procedure which has been in place for well over a decade and follows the State FOP policy and procedure. The policy consists of criteria such as incumbency, the candidate's position on Lodge 7 issues, position on public employee issues, legislative experience, work experience, political experience, the ability for the candidate to conduct a viable campaign, i.e., campaign staff size, volunteers (door knockers), funds on-hand, fund raising, campaign strategy, voting records, bill sponsorship, opinions of other police organizations, etc., and chances of winning.

On December 28th, 2011 and January 9th, 2012, the PAC held interviews with

candidates seeking the Lodge 7 endorsement. Upon the conclusion of all interviews, the PAC came up with recommendations, which were then reported to the full Board of Directors for discussion and voting on the endorsements themselves. The Board of Directors is not required to make an endorsement just because requests and recommendations have been made. In addition, Lodge 7's endorsements cannot be in conflict with the State FOP. The endorsements made by Lodge 7 are recommendations for our members and members have the right to vote for the candidates of their choice.

## Financial Secretary's Report, By Rich Aguilar



### Now You See Him, Now You Don't Let me start by boring you

with a brief psychology lesson. Swiss Developmental Psychologist Jean Piaget proposed a devel-

opmental theory that included the Theory of Object Permanence. This is a simple theory that is best illustrated by placing a toy in front of a young child. The child sees the toy and is delighted. The toy is now placed behind a box. The child cannot see it and in the child's mind the toy no longer exists. Many parents unknowingly use this concept when it's time for bed or time to do something else. They take the toy and place it out of sight. Unfortunately, these parents soon discover that their children reach a stage of development where they realize that the toy is still there even when they can't see it behind the box. The child has now moved on to a stage in his development where he is aware that the toy is never really gone.

As a new Police Officer on the street almost thirty years ago, I was often amused that apparently many of the bad guys and almost all of the prostitutes walking the street had not moved on to this next stage of development. When approached by Police Officers, they would avert their eyes or look the other way and, at least in their minds, the Police Officers didn't exist. In many cases, there was even a look of surprise when confronted by the Police as if to say, "Where did they come from?"

I always assumed that all Police Officers had moved on to the next stage of development where they realized that just because they could no longer see something didn't mean it had ceased to exist. I guess I was wrong.

For years, the most senior Police Officer assigned to District Desk Duty who assumed the duties of a Desk Sergeant was paid out of grade as the Acting Desk Sergeant at the D-3 rate of pay as required by our Collective Bargaining Agreement with the City of Chicago. All the Officer had to do was submit an out of grade slip.

Recently, the Department reorganized District Operations when it issued Special Order S03-03 on January 3, 2012. The Department immediately began denying the Desk Officer's request to be paid out of grade as the Acting Desk Sergeant. Several Officers contacted the Lodge and they were advised to file grievances in order to resolve the issue. Management and Labor Affairs Commander Donald O'Neill contacted the Lodge after he had received several of these grievances. He wanted to know what they were about even though he was aware of the order and the grievances were clearly worded. It was explained to him that our members were being denied out of grade pay as the Acting Desk Sergeant. What was his response? The Desk Sergeant position no longer existed. It seems that the Commander may be developmentally challenged as he now believes that the Desk Sergeant no longer exists because the Department has put a new hat on the Desk Sergeant and is now calling him the District Station Supervisor. It's kind of like the example of the street people who believe that the Police don't exist if they don't see them.

What the Commander has conveniently overlooked is the fact that the same duties are still being performed on a daily basis on every watch. He has also overlooked the fact that a Department directive cannot change or circumvent our Collective Bargaining Agreement.

The Department is now requesting To-From-Subject reports from Officers that are to be submitted with out of grade requests. The Department wants these reports to delineate what duties were performed and how long they were performed. This was never a prerequisite to being paid out of grade in the past. Although it is ultimately the affected Officer's decision as to whether to complete this report or not, it is not recommended that this report be completed. Officers are encouraged to document their duties for their own personal records should they be needed at a future arbitration date. Officers should feel free to contact me at the Lodge for information to include in your personal notes.

Some District Commanders are also requesting To-From-Subject reports from Officers before the District Commander will issue a grievance number for a grievance filed by the Officer. There is not any provision in our Collective Bargaining Agreement that requires this. While the Section 9.2 of our contract does state the officer should attempt to satisfy his or her concerns on an informal basis, Officers should not complete this report under any circumstances. The submission of a To-From to any Department member is the submission of an official police report and is not informal in any way. Any Officer who is denied the right to file a grievance because of his refusal to submit this report should contact the Lodge immediately. The Lodge will file an Unfair Labor Practice with the Illinois Labor Relations Board if necessary.

Officers, I realize that this is not an issue that affects the majority of you who are reading this article, but please keep in mind that this is just another example of how our Mayor, Superintendent, and the Department are attempting to erode our contractual benefits bit by bit. Make no mistake about it. The attack is on. Contact the Lodge immediately if you believe that your contractual rights are being violated. This is the only way to ensure yours and your fellow Officers protection.

Just as this article was coming to a close I received a copy of an inter-office memo that was distributed to the members of the Marine Unit. The memo states that the use of Out of Grade Work Authorization forms for Acting Sergeant is strictly prohibited..... Also, prior to performing a dead body removal, notification will be made to Lt. Erroll Davis who will obtain approval from the Chief of Special Functions Division.

## Disability Committee Report, By Mike Lappe, Chairman

Hello to all from the disability committee. I would like to state that all is well, however, we find ourselves in the middle of what I would call a tornado. Unprecedented policy changes have been implemented (without contractual impute) by the Chicago Police Medical Section, Human Resources and the City. Cancelation of an officer's duty status for a non-duty related event is under fire and is currently being addressed by the FOP Board Members.

Also, officers who are on medications from a duty related IOD got the surprise of their life when they learned that their prescriptions were cancelled. I know this for a fact, because mine was. This is what happened: before heading out to work, I phoned Medco Home Pharmacy as my meds were being depleted and I had two remaining refills. (I'm not shy to tell you the meds are to control internal bleeding as a result from receiving a GSW to my throat. I will remain on this prescription for the remainder of my life).

I made a direct line visit to the Medical Section to ascertain why Medco cancelled me after 24 years of home pharmacy. Several calls were placed by the officer/ nurse who cut through the BS. We both learned that I was canceled on 03 December 2011. No person would say by whom or why, but I was then provided the phone number to "First Script" as this outfit manages all medications for duty related IOD claims. I was then reinstated and instructed for refills in the future call 1-877-350-5160.

If we have retired officers out there who may be out-of-state, be advised if you're in a similar situation you need to check with your home pharmacy to ensure that you have not be cancelled. Don't wait for the last minute. You need to stay on top of this issue.

#### **Focus Group Recruitment Announcement**

Volunteers are being sought to participate in a research study being conducted by faculty members in the Department of Criminal Justice and Criminology at Loyola University Chicago in cooperation with the Chicago Fraternal Order of Police (FOP). The purpose of this study is to obtain the views of police officers and detectives about policing in Chicago. We are interested in learning your experiences and the impact of criminal justice policies on your day-to-day work routine.

The research will begin with the convening of focus groups, which are group interviews of approximately six persons in each group. The groups, four of which will consist of patrol officers and one which will consist of detectives, will meet for approximately two hours. During the discussion, participants will be asked questions about how criminal justice policies and those of the Chicago Police Department affect their day-to-day experience on the job. Participants' responses will be used to construct an online survey to the FOP membership about the same subject.

If you agree to participate in one of the focus groups, the information that you provide will be kept strictly confidential. The fact that you participated in the study and the responses you gave will not be shared with any person in your agency or with any other agency. Even if you decide to participate, you will be free not to answer any question, or to withdraw from participation at any time without penalty.

If you would be willing to participate in one of the focus groups, please contact Kelly Clark. You will be asked to identify yourself only for purposes of contacting you for focus group scheduling purposes. You will also be asked to provide some information, such as whether you are a patrol officer or detective, your gender, the length of your service in CPD, your age, and your race, so that the focus groups fairly represent the diversity of the CPD population. If you are accepted for a focus group, you will be contacted by an FOP representative who will schedule your participation.

I was out on the street during the Holidays The family ate together at the table, but the elderly grandfather's shaky hands and failing eyesight made eating difficult. Peas rolled off his spoon onto the floor. When he grasped the glass, milk spilled on the tablecloth.

> The son and daughter-in-law became irritated with the mess. "We must do something about Grandfather," said the son. I've had enough of his spilled milk, noisy eating, and food on the floor. So the husband and wife set a small table in the corner. There, Grandfather ate alone while the rest of the family enjoyed dinner.

> Since Grandfather had broken a dish or two, his food was served in a wooden bowl. When the family glanced in Grandfather's direction, sometime he had a tear in his eye as he sat alone. Still, the only words the couple had for him were sharp admonitions when he dropped a fork or spilled food.
