

President's Report, By Michael Shields



Manpower

With a single stroke of a pen, the City's budget director, Alex Holt, removed well over 1,300 Chicago Police Department vacancies. After the first stretch of warm weather, it has become blatantly obvious that the budget was balanced at the expense of public safety. We continuously hear about the Emanuel administration's "doing more with less" philosophy. In general, this is a misguided and shortsighted operational strategy; in law enforcement it is

reckless and potentially deadly. It seems pretty clear to me that in the case of the Department's manpower shortage, less equals less. The only things I see more of? More homicides, more danger faced by the men and women of this department and more threats to the public and to officer safety. We cannot adequately police this city with this shortage of officers on the street.

On Tuesday, March 20th, Superintendent McCarthy responded to the surge in violence over the previous weekend by telling the Chicago Sun Times that there isn't a pressing need for more police officers. He said, "Crime reduction is not a matter of how many officers we have but how they are deployed, what they do and how hard they are working." Yet, so far this year, there have been 94 murders compared with 66 last year, and 408 non-fatal shootings compared with 296 in 2011. This is to say nothing of police-involved shootings and officers shot, most recently Officer Del Pearson. I don't know a single Chicago Police Officer besides our Superintendent who says we don't need more manpower in order to combat this increase in violence.

On March 19th, the Chicago Tribune reported that the demonstrators for G-8 and NATO Summits have requested a change in permit. The Tribune reports that the "City rejected this request, citing a lack of police officers..." based on statements made from CDOT. Clearly, the Chicago Department of Transportation understands that there is not enough manpower. Unfortunately, the right hand of the City is in conflict with the left. All the CPD press conferences in the world cannot justify this manpower crisis. We need to hire more police.

Play The Whole Video

Recently, I watched coverage of a police related story on TV that depicted a good police officer badly. An officer working alone on the crowded Clark Street in Wrigleyville was shown grabbing a young man by the throat, walking him out of the street where the officer wasn't surrounded by a crowd, placing him on the ground and holding him there while he radioed for help. The officer did not punch the young man. The officer did not kick the young man. There was no excessive force of any kind. In fact, anyone who watched the video can easily see that the officer uses care in making sure that the young drunk is not injured.

If you listen to the audiotape of the incident, the crowd is clearly on the side of the police officer. There are numerous people remarking about how stupid the young man is for challenging the officer. No one is yelling "police brutality." No one is angry at the actions of the police.

And no one would be angry at the police officer if they watched the entire video. It shows the young man clearly trying to pick a fight with the officer. He jumps up and down right in the officer's face. He gives the officer the finger. The man's girlfriend clearly knows that he is way out of line as she tries desperately to pull him away from the police officer.

But here is the problem: Viewers of the TV news don't see any of that. They just see a larger police officer grab and restrain a young man. The news channel stated they don't know what led to the incident. *I* clearly know what led up to this. When you watch the entire video, it tells a different tale. You can also see another, earlier video of the same idiot assaulting a bar bouncer and acting like a complete fool just before his encounter with the police officer.

The TV news just edited the video so it are losing viewers and advertisers. starts with the officer grabbing the young man. When I was asked what FOP's reaction to the video was, I simply stated, "When citizens of Chicago head to the bars on Clark St., they know that they can walk safely down the street because of [the officer that you see in that video]."

The police officer in the video did a great job of controlling an unruly drunk who was hell bent on fighting someone. The officer did his job appropriately and without causing unnecessary injury to the man. He should be commended. Instead, he gets cast in a false light by our local media – and the media wonders why they

Let's hope that IPRA reviews all the available evidence - unlike the media and enters the correct finding of "exonerated" on this particular CR.

Why Does The **Committee on Finance Waste Money?**

The Lodge received another arbitration decision winning a slip and

fall case. The Committee on Finance believes that when an officer is doing his or her job and is injured in a fall, the injury is not compensable. That is what the letter states when the officer receives their denial from the Committee on Finance stating: "alleged injury not compensable". Now the Committee on Finance may say that isn't true, and that if the officer is doing their job and they get hurt they will be covered. Here are the facts of this case: An officer was working in Englewood; as we all know as a very violent and high crime area. The officer observed a vehicle pull away from the curb at a high rate of speed. The officer stopped the vehicle thinking that a crime had occurred and found that there was a victim of a stabbing inside the vehicle. The victim stated that a female had just stabbed him and she was just standing at the curb. The officer returned to the scene and a citizen informed him that the female had went into the apartment building. The officer went into the building which was dark and went up the stairs looking for the offender. The same citizen informed the officer that the offender was fleeing out another exit. The officer turned to go down the stairs, missed a stair, fell and broke his ankle. So just to sum this all up,

an officer injuries himself chasing after a violent offender and the position of the Committee on Finance is that the injury is not compensable and won't be coded as

Apparently, the Committee on Finance believes that an officer going up and down the stairs chasing an offender is no different than Joe Citizen going up and down the stairs every day. I didn't realize that Joe Citizen chased after violent offenders in Englewood while walking up and down the stairs every day. It is the responsibility of the Committee on Finance to see to it that officers receive proper medical care and treatment when an officer is injured while performing his/her duties. The Committee on Finance has the responsibility of investigating claims when officers are injured on duty. Luana Montoya, the Executive Director of the Claims Division testified that the Committee on Finance conducts investigations for injuries on duty. What she didn't testify to is whether they were competent investigations.

Because of the poor investigation, both the Lodge and the Department had to go in front of an arbitrator and have him tell the City that this injury on duty should be certified. The Arbitrator granted the grievance and directed the City to make the officer whole for any loses he may have suffered as a result of the City violating the Collective Bargaining Agreement including monies expended for medical treatment and coding

the injury as "Code 1, IOD".

Once again, the City spent thousands of dollars fighting the IOD claim of an officer who was clearly performing a police function.

Medical Mediation & Limited Duty

Medical Grievances have increased 200% since the Department made the new changes in the Limited Duty Order E03-01-03. This has increased the workload for the Lodge and the Medical Services Section (MSS). The difference is the Lodge can handle the workload, but the Medical Section can't. The Lodge had Medical Mediation on March 22, 2012. There were 24 new matters on the agenda and 12 follow-ups. When the Lodge files a grievance, we get the medical file from the MSS usually one or two days before mediation. For the March Mediation, there were ten medical files that the MSS refused to send over. At Mediation, they explained that it was not possible for MSS to copy these files and get them to us with without at last two weeks notice. They only had 10 days to copy the missing files. We explained to everyone on the City's side of the table, which includes their overpaid lawyer, the doctor and medical administrator from MSS, the Commander of MLAS and his sidekick, two employees from the Committee on Finance and Deputy Chief of Bureau Administration that in almost all of these cases, the officers were being paid to sit (Continued on page 3)

at home when their treating physicians had submitted letters stating that these officers could work in a limited duty capacity. We all wondered why with the Department being short handed would they pay officers to sit at home. Now you would think with all the bodies on the City's side of the table, someone over there would say this is stupid. You would be wrong.

Spring Uniform Resale

Clemency Hearing for a Cop Killer

The Lodge was recently contacted by the Cook County State's Attorney of a clemency hearing which has been scheduled before the Illinois Prisoner Review Board for the convicted murderer of PO Anthony Rizzato, Star 12407 and Sgt James Severin, Star 1319 of the A/6/Task Force, EOW 17 July 1970. The hearing is scheduled for 10 April 2012 at 0900 hrs at the Illinois State Building, Room 09-040.

This same murderer was granted a parole hearing in the summer of 2011. He was denied parole for these brutal murders and was given a 3-year set before the case may be heard again. The murderer, not satisfied with the Parole Board's decision, filed a petition for executive clemency with the Governor's Office. I, along with other representatives of the Lodge, will attend this hearing to support the families and friend and partners of the murdered police officers. The Lodge will strongly voice our opposition that clemency should not be granted to this murderer who should serve the remainder of his lawful prison term. WE WILL NEVER FORGET!

Firearm Safety Reminder and FOP Firearm Safety Days

Semi-automatic pistols require additional care and maintenance. Depending on the exposure to the elements, it is required to clean and lubricate these handguns monthly to ensure safe operation. It is also recommended that these weapons be inspected annually by a factory authorized technician who will strip, clean and inspect these weapons. The Lodge annually hosts a Firearms Safety Days where this service is provided at no cost to our members. The Lodge will be hosting the next Firearms Safety Days on 13& 14 June 2012 at the Hall from 0900 hrs until 1700 hrs. There will be representatives from the approved firearm manufacturers who will be on site to conduct safety inspections of our members duty related weapons.

Take full advantage of this worthwhile event which the Lodge has provided as a benefit. An ounce of preventative maintenance could make the difference during a critical moment.

Warm Weather and Pre-Summer Violence in the Streets

March 2012 produced some of the most unseasonably warm conditions dating back over 50 years. As a result of this warm weather, a surge in violent crime has risen in our City. The news reports indicate over 50 persons were shot over a 5 day period with at least 10 killed, one of who was a 6 year old child and another included the attempted murder Chicago Police Officer who was shot and injured in the performance of duty.

Though each of these incidents is equally violent, they are also a slap in the face of society. The newspapers and media outlets give different reasons or causes for the increased violence across the City, but the bottom line is, there is no respect for the communities where these thugs live and ply their unlawful

enterprises. These urban terrorists do not fear anything which obstructs their unlawful ways of life. There are always reports on different causes of this violence from drug and gang turf to a verbal disagreement which can escalate to someone being shot. The politicians, news media and social scientists all put in their own claim to prevention and solving these problems. Even the Department is attempting to apply different policing and management techniques.

Our Department is experiencing many organizational changes with the closing or merging of Police Districts and Detective Areas. The Department has also recently disbanded several large immediate response units, which were responsible for patrolling Districts by providing additional support, manpower, and enforcement actions where needed. Now these Units are gone; all of the Officers relocated throughout the City for no good reason other than a politician or administrator decided it would put more cops on the streets, which is just smoke and mirrors. These disbanded officers were all ready on the streets, providing support and a valuable service which is required for these extreme and violent conditions. Everyone is talking about how busy and violent the City streets have been with this warm spell in March. What will we do when the temperatures remain warm for a few months? The NATO Conference and the warm summer months are approaching quickly and I can only hope that those charged with the planning and administration of this Department keep in mind how to best utilize and deploy officers to protect our City. The dedication to duty which was displayed by all during this violent period resulted in some of the finest police work performed by the members of this Department. The best advice I can give to our officers during these difficult and violent times is to stay alert, be prepared and watch each other's backs. Be Safe!

IPRA Fast Track Investigations, By Jim McCarthy, Field Representative



At a recent Legal Defense Committee meeting one of our members appeared before the Committee to request legal coverage for his upcoming Police

Board Hearing. Shortly before Christmas Day in 2006 this member was involved in an incident outside of a North Side bar. His letter from IPRA informing him that he was facing 30-days pending separation was dated January 10, 2012. Based on his appearance before the Committee I personally believe he has an excellent chance of success before the Police Board. However, the merits of his case are not at issue in this article. The issue is: why does it take IPRA over 5 years to investigate ordinary allegations against police officers? When asked at meetings as well as at arbitration, the City has yet to supply a plausible explanation. Pursuant to an appeal of a Police Board decision, the City was unable to provide a credible explanation to Cook County Circuit Court Judge Kathleen Pantle either. In fact, Judge Pantle held, "The Superintendent essentially conceded both at the administrative level and at oral arguments here in court that the lengthy delay could not be explained."

As a result, on March 1, 2012 Judge Pantle reversed a Police Board decision that terminated the employment of two police officers. Judge Pantle held that the amount of time in between the March 24, 2006 incident and the July 2010 dismissal notice was unreasonable and prejudicial to the officer's case before the board. This IPRA investigation centered on a complainant who per the Judge's Order "had four felony convictions at the time he testified. Three of the felonies were for possession of a controlled substance and the fourth was for aggravated battery to a police officer." Surely, not the caliber of individual you would find roaming around an Ivy League campus but for an IPRA complainant a very run of the mill background indeed. Judge Pantle further held that the practice of carrying out disciplinary investigations over the course of several years is in violation of City Mu-

At a recent Legal nicipal Ordinance 2-57-070 as well as efense Committee General Order 93-03.

As part of her order, Judge Pantle touched on administrative due process and how it applies to public employees by way of directly quoting former Supreme Court Justice Brennan. "Today the Court puts to rest any remaining debate over whether public employers must provide meaningful notice and hearing procedures before discharging an employee for cause. As the Court convincingly demonstrates, the employee's right to fair notice and an opportunity to 'present his side of the story' before discharge is not a matter of legislative grace, but of 'constitutional guarantee'" Id. at 541, 546, 551, Brennan, J concurring in part, dissenting in part.

Ironically, IPRA Director Rosenzweig has been a featured guest lecturer before the Chicago Chapter of the American Constitution Society (ACS) regarding disciplinary investigations of Chicago Police Officers. ACS is a progressive constitutional think tank and according to their website, "works for positive change by shaping debate on vitally important legal and constitutional issues....by countering the activist conservative legal movement that has sought to erode our enduring constitutional values." Under the Chicago Municipal Code Director Rosenzweig is mandated with the task of conducting disciplinary investigations, "consistent with due process of law and equal protection under the law." Yet, when the Director is directly asked about this issue, she does not seem the least bit bothered or interested in extending any type of due process or equal protection to the Chicago Police Officers she investigates. Under Illinois criminal law almost all felonies have a statute of limitations of three years. Several of the internal investigations conducted by IPRA and IAD double in the length of time allowed under Illinois statute of limitations law. Although, there are supposed time constraints for disciplinary investigations as cited in Judge Pantle's order, various city and department officials insist no such time requirement exist. With policy interpretation like this, were he still alive legendary Chicago Police Officer Frank Pape (1933-72) would be shaking.

At present there are several cases

headed to the Police Board which stem from incidents 4 to 5 years ago. Now a normal logical person, like Judge Pantle, would likely reach the conclusion that older incidents such as these should probably be settled without a Police Board hearing in order to avoid any further embarrassment. I was hoping that based on the aforementioned court order, that Director Rosenzweig might read the order and look at the logic behind it. Sadly, but not surprisingly, that was wishful thinking on my part. While writing this article a 20-year member stopped into my office seeking counsel for a separation case stemming from August of 2007. particular investigation actually took slightly less than 5-years. So by my calculations this member has spent almost one-fourth of her career under internal investigation.

In closing, I truly wonder what has to take place in order for IPRA/IAD to realize that the practice of disciplinary investigations which take place over the course of several years is truly shameful. The Chicago Police Department and rightfully so, mandates that the Detective Division complete criminal investigations, both in a timely manner and in accordance with state law. Conversely, when it comes to IPRA investigations of its own members, the department stands idly by refusing to challenge what are clearly incompetent and unjust investigations.

I have been a Field Training Officer for some twenty-five years now. I have worked with several outstanding recruits during that time. You all know who you are.

There are several incidents involving many of the recruits I have worked with that stand out in my mind. One, in particular, seems to have great significance as our Officers face some challenging and trying times while working the street in our current environment. I am sure you can relate to this if you are working as a Police Officer today.

It was a normal day in the 014th District back in the late 80's. I was assigned to a beat car working with a recruit who was in his first few days of training. As we were patrolling the beat, we approached a group of gangbangers hanging out on the corner. As we got closer, the gangbangers dispersed without a word from either of us in the squad car. The recruit looked somewhat amazed that our mere presence could evoke such a response from this group.

After a few minutes, I could see that the recruit wanted to say something but seemed reluctant. He finally spoke his mind after a little prodding. I remember his statement like he said it yesterday. He said, "You do know that they didn't leave because they respect us. They only left because they fear us."

I have to admit that I never really thought about it. When I did give it some thought I realized that I really didn't care how we got them to comply or why they did. All I knew was that I got the response that I wanted as a Police Officer. They left. That is exactly what I told the recruit.

Fast-forward to today. The problem almost jumps out at you. Today's criminals on the street still do not have any respect for the Police, but even more importantly; they no longer have any fear of the Police or the criminal justice system. They are more than aware that we are

shorthanded. They are more than aware that there are video cameras everywhere that record incidents and create videos that, when taken out of context, portray the Police Officer as the criminal. They are more than aware that the media will post a graduation photo and portray them as honor students. They are more than aware that there is always a law firm willing to represent them, regardless of their backgrounds, as long as there is a chance for money to be made.

It should not be any mystery why batteries against Police Officers are increasing every year. It should not be any mystery why shots fired at Police Officers are increasing every year. It should not be any mystery why weapons pointed at Police Officers are increasing every year.

We are frequently portrayed as the trigger happy Police. We are criticized that we are quick to shoot and ask questions later. Nothing could be further from the truth. Police Officers do not go to work thinking, "Gee, seems like a good night to go out and shoot someone." On the contrary, Police Officers would prefer to go through their entire careers without ever having to discharge their firearm. The decision of whether a Police Officer shoots or doesn't shoot is **always** deter-

mined by the actions of the criminal himself.

A True Role Model

There is a man in the Chicago Police Department who can serve as a role model to all members. He is an alumnus of mine from Lane Technical High School. This man works countless hours to make a Police Officer's job easier and more satisfying. He is a decision maker who always has the best interests of Police Officers in mind. When his team makes an offer to reduce a suspension he would never think to then back out of that deal and embarrass his team and/or the arbitrator involved in the process.

Disability News, By Mike Lappe, Chairman

As we currently witness more officers applying for placement on the duty disability roll through the pension fund, you need take note that a backlog has been created that has slowed the distribution of funds to the officer for his or her duty disability. The cases that hit a snag are ones where an officer has been on limited duty for a few years.

The CPD Human Resources Administra-

tion's new guidelines (that this FOP committee believes were created on a whim without being intelligently thought out) now put the Chicago Pension Board in limbo. There are no clear cut guidelines until the new policy that demands a limited officer catch a bad guy or two can be agreed upon and/or stricken as a requirement to remain on limited duty. So take note if you fall into this category and are being forced to apply for disability.

Take note that no delays have been mentioned for officers who applied for ordinary or occupational disease disability.

Lastly, in the event an officer sustained an on-duty serious injury, (GSW, trauma from a MVA, etc.) there would not be any delay in cases such as these. The Pension Board applies common sense to make the officers transition as least painful as possible.

The IPA is the largest and oldest organization for police officers in the world. The founder, Arthur Troop (1915-2000), a police sergeant was born in Lincoln in the English county of Lincolnshire.

The association was founded on January 1, 1950 under (Service through friendship) to create friendly links and encourage cooperation between individual police officers around the world. IPA has about 400,000 members and sections in 63 countries.

The U.S. Section has approximately 10,000 members. Region 4 includes Chicago, Northern Illinois, Iowa and Nebraska and has about 300 members. IPA holds meetings and other events through-

out the year in the Chicago area.

Benefits of IPA membership include education, travel, benevolence, networking, travel opportunities between sections, organized events, friendship weeks and hobby and collector groups.

One of the many advantages of the IPA is the availability of expert assistance for travel in foreign countries often at a greatly reduced cost or not cost at all. Many members of IPA have attained lifetime friendships with IPA people abroad.

New members receive an ID card, which is recognized world-wide as an official membership identification. Each member receives a copy of the quarterly National Reporter, and copies of their respective Region's newsletter. IPA is open to all active and retired law enforcement officers.
