Acting President's Report, by Bill Dougherty, 1st Vice-President



Attention Pensions

We are asking all of our members to visit the offices of their respective State Senators and Representatives during the week of 10 March, to deliver the message that the City has failed to pay a sufficient amount to secure proper pension funding levels even after getting direction from their own actuary. The City cannot be allowed to push this issue down the road any longer. They must identify a new revenue source to properly fund our Pensions. The law that

requires actuarial required contributions (ARC) has been on the books for over three years now. That ARC funding law needs to stay in place and the City needs to honor the law, not attempt to dismantle it and deepen the pension problem. Please, go see the folks who will ultimately decide this part of your future. Be firm, but be polite.

We Are One Chicago Campaign

On February 17th, we held a press conference that had city workers themselves talking about how a diminished pension would affect the lives of their families. On February 19th, the We Are One Chicago campaign sent a contingent of city workers to Springfield to send a message to legislators and City Hall that we will not stand for politicians passing legislation that diminishes our pension contracts. There were over 1,000 city workers and retirees that stood together and let the legislators know that we will be down there in force if the Mayor submits any pension bill that affects our members. Alderman Bob Fioretti and Alderman Ricardo Munoz stood with city workers in support of our pensions. We cannot stand by and expect everyone else to carry the load, at the very least each of our members must call their legislators. At the very least we must call them and let them know that we have always lived up to our contract and placed 9% out of each paycheck into the pension fund since the day we came on the job. Don't let them diminish our pensions. Call 1-888-412-6570 and let your State Senators and Representatives know how we feel.

Military Leave of Absence Act

The Lodge recently represented an officer who filed a charge of discrimination at the Illinois Department of Human Rights. The officer is a member of the United States Army Reserves. At various points throughout 2013, she attended mandatory drill weekends as part of her Army Reserves duties. The Illinois Military Leave of Absence Act provides that the City of Chicago must pay regular compensation to the officer minus any amount that she receives in payment for her military activities. The Department made this veteran use compensatory time for her training.

The City of Chicago has not yet filed its written response to the charge. However, I would hope that the Police Department brings itself into compliance with the law immediately. We all owe a debt of gratitude to our men and women in the armed forces, and it is insulting that we even had to file this charge. The Lodge will keep you posted on the outcome of this important case.

Flexible Spending Account (FSA)

If you participated in the FSA in 2013 and you don't use all your money designated for 2013 in your account before March 15, 2014, and submit the claims by March 31, 2014, your remaining balance for 2013 will be forfeited. For a list of eligible healthcare expenses, visit the Payflex website at HealthHub.com or call Payflex at 1-800-284-4885.

Condition of Department Vehicles

The Lodge gets numerous complaints from officers that the condition of Department vehicles is getting worse. The Department's position is that a vehicle is not

removed from service on mileage alone. A vehicle is only removed when it is unsafe for use. The Department claims that officer safety is the number one priority when deciding to leave a vehicle in service or remove a vehicle from service. The Department is also aware that we don't bring in vehicles because of a lack of pool cars. We need officers to start downing these unsafe vehicles. Take pictures of these vehicles and refuse to drive a vehicle that you believe is unsafe. We have a proposal in contract negotiations that will address this issue, but we need officers to document what is unsafe about their vehicles.

Emergency Motion for a Temporary Restraining Order

On Feb 11th, Suspended President Mike Shields filed an emergency motion in the Circuit Court, Chancery Division. Mr. Shields wanted to stop the election ballots from going out in order to have himself placed on the ballot after failing to submit to file his petition to run. The Judge heard both sides and ruled that there was no emergency and that the ballots could go out. Judge Valderrama also ruled that there was no valid reason why this motion was being brought at the eleventh hour. The case will return for status on March 13th.

Hearing Against Suspended President Shields

The hearing against Suspended President Shields went forward on Feb 21st. The committee will present their findings at the March 4th Board of Directors meeting. Board meetings are open to all members of the Fraternal Order of Police.

Discipline Screening Program

Officers, when a CR Investigation is sustained and there is a recommended penalty of fifteen (15) days or less,

the first step in the Officer's appeal process is the Discipline Screening Program (DSP). The officer will be notified of the sustained finding and recommendation of the penalty. The officer will be advised that he or she may accept the recommended penalty or request the Discipline Screening Program, and must return the form within 72 hours of making a choice. If the officer chooses the DSP, he or she must notify the Lodge, and the Lodge will request the CR file. At some time in the future the officer will be notified of the time and date of the DSP.

Prior to the DSP, the officer will have the ability to come into the FOP and review his/her CR file with an FOP representative. The DSP will be held with a representative of the Department and the Lodge in attendance. They will review facts of the case which were used to reach the original recommendation for discipline. If an agreement is reached, that recommendation will be forwarded to the Officer who will have two options: accept the recommended penalty or reject it.

If the Officer accepts the recommended penalty at the DSP, this penalty is binding on the Superintendant who can only decrease the penalty or grant options. If the original penalty is 1-5 days, the officer will serve the suspension. After the suspension, the officer will then file a grievance as outlined in our contract. If the recommended penalty is 6-15 days, the Officer has the option of a Police Board Review. This is a paper review only (To-From Report) directed to the Police Board with the goal of changing the finding or reducing the recommended penalty. The Lodge will assist the officers in writing their appeal to the Police Board. The deci-

sion of the Police Board is final and cannot be changed by the Department. If the Police Board decision is to sustain the recommended discipline then the Officer will serve the suspension. The Officer will then file a grievance for just cause section 8.1 of the contract.

Appendix T Random Drug and Alcohol Testing

As a result of the Arbitrators Award effective 1 January 2012, changes and revisions are made in the Department's Random Drug Testing program. Officers selected for Random Drug Testing will now also be tested for alcohol.

Upon being notified, officers will report to the Random Drug Testing Unit for collection of urine specimens. The Department may test the results of the urine sample for the presence of both drugs and alcohol. The Department may also test for alcohol using a breath alcohol test administered by a qualified tester using a certified and calibrated Breathalyzer. If the test reveals a level of .021-.039 the Officer shall be relieved from duty without compensation until the next day and shall submit to drug and alcohol testing prior to his/her return to duty.

If the return to duty test reveals a alcohol level of .00 the Officer may return to duty and shall not be

the subject of discipline based on the initial test result however during the six month period following the date of the initial test the Officer will be selected for random drug and alcohol testing from an eligibility pool consisting of similarly situated Officers.

If the return to duty test or any test administered within the 6 month period reveals any presence of alcohol the Officer shall be relieved from duty without compensation until ordered to return to duty and the Random Drug Testing Unit will refer the matter to Internal Affairs Division.

If the test reveals a breath alcohol level equal or greater than .04 or its urine concentration equivalent the Officer shall be relieved from duty without compensation until ordered to return to duty and the Random Drug Testing Unit will refer the matter to Internal Affairs Division.

In the event discipline is recommended IAD shall consider whether to agree to hold the discipline in abeyance in exchange for the Officer's agreement to participate in a rehabilitation program and remain drug and alcohol free for a defined period and comply with other appropriate terms and conditions

An Officer who is relieved from duty without compensation in accordance with this subsection may utilize accrued elective time during this unpaid period of absence.

From the Desk of Marlon Harvey, Field Representative



Concealed Carry and Retired Officers In last month's February Newsletter, I provided information to help guide retired Police Officers in the process of obtaining an

Illinois Retired Officers Concealed Carry card, better known as the IROCC card. In the February article, my instructions suggested that the retired officer should obtain documents verifying "good standing," from the Chicago Police Pension Office. In this article I would like to note to all that the required step of acquiring the needed verification of "Good standing" must come from the Chicago Police Department Office of Human Resources Department 3510 S. Michigan Ave, Chicago IL, 60653. The Chicago Police Pension office will assist the retired officer with matters pertaining to the retirement process, however verification of law enforcement employment for the IROCC card must come from the "EMPLOYER OF RECORD," which in our case would be the Department.

There is a rare exception. In the instance where an Officer is placed on disability prior to retiring, he will need to contact the Pension Fund to determine the accumulated period of service while in a disability status. This can be provided to the officer via a written letter and sent to his/her residence. The officer will then be able to present this letter, along with the IROCC application to the Department's

Human Resources office.

HR218 requires that the officer have ten years service as a law enforcement officer. Oftentimes the officer still qualifies for the IROCC card upon changing to retired status. Just recently I assisted a retired officer in this very same circumstance in applying for the IROCC card. We sat down together in the Human Resources Department and went over the IROCC application that he downloaded from the website www.irocc.org. FORM 3 of the IROCC application is the page Human Resources will complete. Personnel in Human Resources were helpful and provided the retired officer with the documents he needed to submit with his application. Contact Ms. Jermaine Hooks of Human Resources at 312-745-5386 to make an appointment.

Officer Safety

Licenses allowing citizens to carry concealed firearms are being issued starting in March. As a matter of fact, as of this writing I am certain that hundreds if not thousands of Concealed Carry licenses have been mailed out already to citizens. This means that the chances have increased significantly for law enforcement officers to have contact with an armed person. Make no mistake here. This article is not about the rights of a citizen to posses a firearm. This is solely regarding officer awareness and safety. I was able to obtain information from the IL State Police office that is involved in the CCL process. As of 18 February 2014,

there were 10,214 CCL applications received from Cook County residences alone. The first licenses were scheduled to be mailed on 28 February 2014, which means licenses could already be in the hands of citizens as you read this.

It is extremely important that every Police Officer working in any field capacity utilize his or her training and sense of safety at all times. Any contact that you may have including calls for service, traffic stops or emergency calls, could mean encountering a possible armed person. In the blink of an eye a seemingly harmless encounter can turn into an attempt to affect the arrest of a now armed offender. The Public Safety Act 430 ILCS 66/10 (h) & (e) allows an officer to ask the citizen if they posses a CCL. The citizen is required to declare possession of the card after being asked AND inform the officer of the exact location of the firearm. This includes ALL occupants of a vehicle as well. Be cognizant that there is always the possibility of multiple firearms on or within the reach of the license holder. There is a streaming video scheduled for release by the Chicago Police Department to guide officers encountering possible CCL holders.

I will end with a quote from Sun Tzu, "Victorious warriors win first and then go to war, while defeated warriors go to war first and then seek to win." As always officers, stay prepared and always ready. Stay safe and back each other up. Thank you.
